During the design process, it became apparent that due to varying roadway conditions several of the specified VMS locations would not be able to be constructed utilizing the standard VMS structures and details developed for the Authority's ITS Program. In order to maintain system continuity for the program specified VMS spacing/location, "Non-Standard" site specific designs were developed for overhead sign structures, specialized foundations and the ITS equipment areas for these locations and incorporated into an additional separate installation contract.
