212-06-2014 Recommendation to Enter into Reimbursement Agreement No. 98-14 With IMTT -Bayonne for the Relocation of Facilities Impacted by the New Jersey Turnpike Interchange 14A Improvements Project Ten Year Capital Program No. 39013027 Amount: \$700,000.00

This agenda item seeks authority to enter into a reimbursement agreement for the relocation of existing IMTT-Bayonne ("IMTT") facilities that will be impacted by the construction of Contract No. T300.311, Interchange 14A Toll Plaza & Ramp Improvements. Due to future access and maintenance restrictions, an existing 16" IMTT pipeline under Route 440 and proposed Ramp Port/TP-440 SB is required to be relocated. This agreement will set forth the terms whereby the Authority will reimburse IMTT for the associated work and material costs for the installation of approximately 485 linear feet of 16" pipeline, approximately 260 linear feet of 20" steel casing, two oil caps, two tie-ins and the abandonment of 465 linear feet of the existing 16" pipeline in an amount not to exceed \$700,000.00. It is anticipated that IMTT will begin this relocation in advance of Contract No. T300.311.

213-06-2014 Authorization for the Executive Director to Execute a Cost Sharing Agreement with Sayreville Seaport Associates, L.P. for the Payment of Costs Related to the Design and Construction of the Local Road Improvements Associated with the Garden State Parkway Interchange 125 Improvements Project Borough of Sayreville, County of Middlesex

The Authority is in the final design phase for the improvements to the Garden State Parkway ("GSP") Interchange 125 (the "Project"). Sayreville Seaport Associates, L.P. ("SSA"), the developers of a project on the former National Lead site in Sayreville, have requested that the Authority modify the design to provide certain local road improvements that will facilitate access from the GSP to and from their development. SSA has agreed to contribute \$15 million toward the design and construction of the Project. The amount is attributable to the local road improvements. This agenda item seeks authorization for the Executive Director to execute a cost sharing agreement with SSA with respect to this modified design.

214-06-2014 <u>Authorization to Renew Environmental Liability Insurance with respect to the</u> <u>Authority's Rolling Owner Controlled Insurance Program ("Rolling OCIP")</u>

The Authority currently maintains pollution insurance to protect against environmental risks discovered during construction for projects covered under the Rolling OCIP. Authorization is sought to renew this insurance for an additional three (3) years, at which point it is estimated that these projects will be completed.

Authorization is requested to implement a pilot program to encourage increased employment of veterans by the Authority's construction contractors.

This litigation resulted from a series of personal injury actions by five plaintiffs against the Authority, State Police, and Trooper Shawn Murray, after an August 13, 2010 motor vehicle accident. Outside counsel, as well as the Authority's third party claims administrator Inservco, have reviewed this matter and recommend that the Authority seek a settlement in the amount of \$435,000.00.
