Authorization is requested to adopt the Amended and Restated Series 2013 Turnpike Revenue Bond Resolution to authorize up to \$600 million of Turnpike Revenue Bonds to refund the Series 2003C-1 bonds, the Series 2005A bonds and the Series 2005C bonds for savings. The resolution also authorizes a replacement liquidity provider for the Series 2003C-1 bonds, and any termination, amendment or replacement of the 2003C-1 Interest Rate Swap Agreement that may be necessary. The 2013 refunding bonds may be issued on a taxable or tax-exempt basis. The \$600 million of refunding bonds is in addition to the \$1.4 million of new money bonds to fund the \$7 billion Capital Investment Program that were previously authorized at the December 2012 meeting.
