The Authority seeks to declare the above property, which it previously purchased for the Route 92 project, as surplus. The Route 92 Project is no longer feasible and as such the Authority seeks to dispose of the property purchased for that project. The above property is triangular in shape and is located along Route 130. The law department has sent around a memorandum to all of the departments and the Authority's General Engineering Consultant-HNTB to obtain certifications that each department does not see any future use of the property before it is declared as surplus. The law department has received all of the certifications signed by each department indicating that they do not see any future use of the property.

Based on current expenditures and anticipated future expenditures through April 2011, the Engineering Department is requesting the authorized contract amount be increased by \$29,500.00. This is due to additional remedial efforts utilizing Multi-Phase Extraction (MPE) events. The MPE process provides direct contaminant recovery from the most impacted areas of the related sites.

The Tolls Department requisitioned a two-year contract for the purchase of 45,000,000 magnetic toll tickets annually. Toll tickets are used by non-EZ Pass patrons who utilize the New Jersey Turnpike and pay a toll value based on the entry and exit locations. Requests for bids were distributed to four vendors. A sole bid proposal was received and came in 6% over estimate. Law and Purchasing Departments staff reviewed the procurement and concluded that given the facts there are other interested bidders and the excessive sole bid amount, it is prudent to reject the sole proposal and rebid the contract in order to foster competition.

In November 2010, the Authority established two accounts for the payment of snow removal contracts on the Authority's roadways. At the start of 2010-2011 snow season, the authorized amount of \$3,911,346.00 was depleted due to significant snow and ice events, and subsequently increased in February, 2011 by the allowable amount of 15%. This increase has also been exhausted, and the Maintenance Department requests an increase of \$4,000,000 to continue snow and ice removal for the remainder of the 2010-2011 snow season, which expires April 30, 2011.
