Under this contract, Rapid Armored Corp. will transport toll and other revenue from the Authority's Roadways. The Services include pick-up from 39 toll plazas on the Parkway and the Turnpike and from 12 Service Areas on the Turnpike. After two unsuccessful public bid attempts, the Board of Commissioners granted authorization for staff to conduct negotiations with available qualified vendors. In addition, the Board delegated to the Executive Director the authority to award the contract to the most responsible vendor after the negotiations. (February 2017 Commission Meeting.) Staff solicited quotations from (six) regional armored car providers and received bids from three vendors: Garda CI Atlantic, Inc., Rapid Armored Corp., and IBI Armored Services, Inc. Rapid submitted the lowest total bid for the three-year contract and staff found that this bidder was qualified to perform the contract. Given that the existing contract with the current provider is due to expire on June 30<sup>th</sup>, the Executive Director issued an award to Rapid Armored Corp. as the lowest responsible bidder for the Services. This Item requests ratification of the award. In addition, during the transition and based on discussions with the Bank, staff concluded that it would be more efficient if the new armored car carrier (rather than the Bank) would provide daily operating funds for rolled coins and small bills to the toll collectors. Thus, staff recommends increasing the authorized amount of the three-year agreement with Rapid by \$418,128 to cover this service. Once the transition phase is completed the agreement with the Bank will be amended to delete this service.
