In addition, notice of said meeting has been and is being displayed in the main lobby of the Authority's Administration Headquarters in Woodbridge.

## **APPROVAL OF MINUTES**

The Secretary reported that ten days (excluding Saturdays, Sundays and holidays) have elapsed since Governor Jon S. Corzine received the proceedings of the January 22<sup>nd</sup> meeting; he has not exercised his power to veto any items in those minutes.

#### **PERSONNEL**

#### 34-08

Deputy Executive Director Scaccetti submitted the <u>Personnel Agenda</u>, dated February 2008, and requested confirmation of the personnel matters contained therein.

On motion by Commissioner DuPont, seconded Commissioner Pocino, employment of those named to serve at the pleasure of the Authority and other recommended personnel actions, were unanimously approved, ratified and confirmed, to become effective as of the dates specified and at the salaries listed.

## **35-08**

Deputy Executive Director Scaccetti presented the recommendation contained in the memorandum dated February 20, 2008, concerning authorization to Enter into a Successor Collective Bargaining Agreement with IFPTE Local 196, Chapter 12, for the period January 1, 2008 through December 31, 2011.

A successor collective bargaining agreement between between the IFPTE Local 196, Chapter 12 ("Local 196, Chapter 12") and the New Jersey Turnpike Authority ("Authority") was submitted for consideration. The successor collective bargaining agreement is a four (4) year contract with a term of January 1, 2008 through December 31, 2011. Made a part hereof is an executive summary noting the major features of the agreement.

One of the most important features of the successor collective bargaining agreement is that retroactive to January 1, 2008, members of Local 196, Chapter 12 will share the costs of health benefits. Specifically, retroactive to January 1, 2008, members of Local 196, Chapter 12 will contribute \$600 per year for the administration of their health benefits and by the end of the contract they will contribute \$900 per year.

The terms of the agreement are fair and reasonable to both the employees represented by the Local 196, Chapter 12 and Authority. Special Labor Counsel joins in recommending that the Authority approve this agreement.

The membership of Local 196, Chapter 12 has not had the opportunity to ratify the agreement. Therefore, approval of a successor collective bargaining agreement between Local 196, Chapter 12 and the Authority for the four (4) year period of January 1, 2008 through December 31, 2011 is respectfully requested pending ratification by the membership of Local

196, Chapter 12. Authorization is also sought to permit the Executive Director to execute the agreement on behalf of the Authority.

# Executive Summary IFPTE Local 196, Chapter 12 Successor Collective Bargaining Agreement

On February 19, 2008, IFPTE Local 196, Chapter 12 and the Authority reached an agreement on a successor collective bargaining agreement for the period of January 1, 2008 through December 31, 2011, subject to ratification by the membership of the union and approval by the Authority's Board of Commissioners.

The key provisions of the successor collective bargaining agreement are:

1. TERM: Four (4) years – January 1, 2008 through December 31, 2011

## 2. WAGE INCREASE:

 1/1/11
 3.5%

The wage increase is the same as that the Authority negotiated with Local 97, Local 193C, Local 194, and AFSCME Local 3914.

#### 3. HEALTH BENEFITS:

a) For the Point of Service and HMO Plans, employees shall pay the following:

1/1/08 \$600 per year 7/1/10 \$800 per year 7/1/09 \$700 per year 6/30/11 \$900 per year

b) Effective April 1, 2008, the Prescription Medicine co-payment at the retail level will be \$3 for generic drugs, \$10 for brand name where there is no generic equivalent or the doctor certifies that the employee is medically unable to take a generic version of the medication, and \$25 for brand name drugs when there is a generic equivalent. This prescription co-payment is the same as that the Authority negotiated with Local 97, Local 193C, Local 194, and AFSCME Local 3914.

The Executive Director certified this agreement recommendation.

On motion by Commissioner Pocino, seconded by Commissioner DuPont, the Authority unanimously approved entering into a Successor Collective Bargaining Agreement with IFPTE Local 196, Chapter 12; and authorized, as presented, the recommendation contained therein; and received and filed the memoranda.

## LAW

Law Director Caceres requested approval of item numbers 36-08 through 39-08; moved as a group, those items are as follows:

## <u>36-08</u>

In the memorandum dated February 13, 2008, concerning the recommendation to <u>Settle</u>

Formal Workers' Compensation Matter of Maryellen Dabinett v. New Jersey Turnpike

Authority, Account No. 10-870-405070.

Maryellen Dabinett, a 57 year old retired toll collector, suffered an injury to her right shoulder at work on 10/21/2002. The injury also aggravated the Petitioner's pre-existing arthritic condition. Despite surgical intervention, the Petitioner remained sufficiently disabled so as to qualify for Ordinary Disability retirement benefits, retiring effective August 1, 2005. This proposed settlement arises out of a formal claim petition filed by the Petitioner for the shoulder injury.

The petitioner is represented by Samuel Gaylord, Esq. The Authority is defended by Special Counsel James Jude Plaia, Esq. The matter is venued in the district office of Elizabeth before Judge Womack.

In this case, the findings of the Authority's medical permanency evaluator are significant at 12.5% partial total disability and serves to underscore before the court, and for purposes of this settlement request, the extensive nature of the injury and aggravation and renders the proposed settlement of 33.337% partial permanent total disability (\$58,600.00) palatable.

Moreover, citing the Petitioner's underlying arthritic condition and it's material contribution to her overall disability, Judge Womak – exercising his discretionary authority – allowed the Authority a 50% credit/offset from the Petitioner's weekly pension benefit, which reduces the Authority's portion of this settlement to \$38,600.00.

The Law Department has reviewed this matter and agrees with the recommendation of the Benefits Manager and Special Counsel. Authorization is, therefore, requested to allow Special Counsel to settle this matter for the sum of \$38,600.00.

## <u>37-08</u>

In the memorandum dated February 13, 2008, concerning the recommendation to <u>Settle</u>

Formal Workers' Compensation Matter of Mark Geisler v. New Jersey Turnpike Authority,

Account No. 10-870-405070.

Mark Geisler is a 50 year old roadway maintenance employee who has been employed with the Authority for 30 years. This proposed settlement is a re-opened claim petition arising out of a previous back/hip injury, which occurred on September 12, 2002. It should also be note that Mr. Geisler, has applied for Accidental Disability retirement benefits, effective January 1, 2008.

The petitioner is represented by Samuel Denburg of Newman & Denburg. The Authority is defended by Special Counsel Gary M. Price. The matter is venued in the district office of Hackensack before Judge Boogle.

Since the original incident of September 19, 2002 and subsequent settlement of 12.5% partial total disability, Mr. Geisler has undergone a total right hip replacement. It is well documented by the Authority's own referring physicians that the Petitioner's degenerative hip disease was aggravated by the nature of his work for the Authority and that he ultimately would require a total hip replacement. As such it is no surprise that the Authority's own medical permanency evaluation only served to confirm causality, thus rendering this issue only a matter of how much the settlement would be. The presiding Judge Boogle settled that matter by placing a value of 37.5% (\$75,375.00) less the credit for the 12.5 % (\$12,600.00) previously paid, for a net settlement of \$62,775.00.

As noted, Mr. Geisler has an application for Accidental Disability retirement pending before PERS. If he is awarded Accidental Disability retirement benefits, PERS will be entitled to reduce/offset his pension by this award. If Mr. Geisler is granted Ordinary Disability retirement

benefits, the Authority shall be entitled to take the offset. Either scenario will take a number of months to determine however, in the interim, the settlement needs to be resolved. Once we have a determination from PERS, the appropriate offset will be applied.

The Law Department has reviewed this matter and agrees with the recommendation of the Benefits Manager and Special Counsel. Authorization is, therefore, requested to allow Special Counsel to settle this matter for the sum of \$62,775.

#### 38-08

In the memorandum dated February 19, 2008, concerning authorization to **Enter into Agreement to Acquire Property In Connection with the Parkway Milepost 30 to Milepost 80 Widening Project**, Parkway Section 10: Parcel Nos. (to be assigned later); Block 14, Lots 6, 7, 8, 9, 10, 11 and 12 – Bass River Township, Burlington County, Current Owner: Evergreen Environmental LLC, Project No. 2060001.

At the February 5, 2007 Commission Meeting, the New Jersey Turnpike Authority (NJTA) awarded OPS No. P3119 to Evergreen Environmental LLC to provide certain wetlands mitigation activities in connection with the proposed widening of the Garden State Parkway between mileposts 63 and 80. At the November 9, 2007 Commission Meeting, Supplement A to OPS No. P3119 was issued, related to the same subject.

Related to this mitigation of wetlands and in order to comply with a permit condition to be issued by the New Jersey Department of Environmental Protection Agency ("NJDEP"), it is necessary for the parties to expedite the creation of public access to be located within Bass River Township, Burlington County. As a result, the parties have identified Block 14, Lots 6, 7, 8, 9, 10, 11 and 12 as properties which will need to be transferred from Evergreen Environmental LLC to the NJTA for the nominal consideration of \$1.00. Parcel numbers will be assigned upon transfer of the property. The NJTA will retain ownership of the Property until all mitigation activities are completed after which time the Property will be transferred to a wildlife conservancy for perpetual conservation.

Therefore, it is recommended that the Executive Director be authorized to enter into an agreement with Evergreen Environmental LLC, after review and approval by the Law Department and outside counsel, for purchase of the Property. It is further recommended that the Executive Director, with the concurrence of the Director of Law and the Chief Engineer, be authorized to execute such documents and take such acts which are necessary in furtherance of the intent of the agreement set forth above.

The following matters were identified in the Public Session agenda:

## LAW

#### 39-08

In the memorandum dated February 21, 2008, concerning authorization to Enter into a 
Programmatic Memorandum of Agreement (MOA) with the New Jersey State Historic

Preservation Office (SHPO) and the United States Army Corps of Engineers (ACE),

Mitigation of Potential Impacts to Historical Resources, Parkway Milepost 30 to Milepost 80

Widening Project.

The New Jersey Turnpike Authority (the "Authority") is continuing with its plans to widen the Garden State Parkway between Interchange 30 and Interchange 80. Since the Parkway has been designated an historic district and the proposed widening will result in adverse effects to characteristics that make the Garden State Parkway eligible for listing in the National Register of Historic Places as a historic district, it is necessary to enter into a Programmatic Agreement with the ACE and the SHPO to implement measures to minimize impacts to historical resources which have been identified by the parties. This would include minimizing impacts to the demolition and/or alteration of five (5) overhead bridges, twenty (20) Parkway mainline bridges, four (4) box or arch culverts, and one hundred thirteen (113) drainage culverts will have an adverse effect on the Parkway historic district.

The parties propose to enter into a Programmatic Memorandum of Agreement ("PMOA") which will identify specific processes intended to minimize, where practicable, the adverse affects of the proposed construction and mitigate such adverse affects that may not be minimized. The proposed PMOA would provide that the Authority perform the following: (1) Host and maintain an historic website previously developed by Atlantic City Electric as part of Atlantic City Electric's agreement with SHPO. The cost of this maintenance is expected to be minimal; (2) Ensure the production of a paperback book about the Garden State Parkway similar to the *Images of America* series by Arcadia Publishing and ensure that a quantity will be made available free of charge by the Authority; (3) Ensure that various construction details including bridges, parapets, abutments guiderail and signs, where applicable, will be compatible with the overall character of the Garden State Parkway historic district. Additionally, it may be necessary to perform other minor historical mitigation at little or no cost to the Authority. Since it would be difficult to estimate the cost of the above obligations with any certainty, should the cost of the obligations under this agreement exceed the Executive Director's delegated authority of \$35,000, Commissioner approval shall be sought before any such costlier undertakings.

Therefore, it is recommended that the Executive Director be authorized to enter into a Programmatic Memorandum of Agreement with the State Historic Preservation Office, and the United States Army Corps of Engineers, substantially incorporating the above terms, and such other terms as may be necessitated by this authorization, after review and approval by the Law Department and outside counsel. It is further recommended that the Executive Director, with the concurrence of the Director of Law and the Chief Engineer, be authorized to execute such

documents and take such acts which are necessary and in furtherance of the intent of the agreement set forth above.

Reviewed by the Human Resources Director as appropriate; available funds certified by the Finance Director where applicable; the Executive Director certified the recommendations for consideration.

On motion by Commissioner DuPont, seconded by Commissioner Pocino, the Authority unanimously approved the four (4) Law items; and authorized, as presented, the recommendations contained therein; and received and filed the memoranda.

## **ENGINEERING**

Chief Engineer Racznyski requested approval of item numbers 40-08 through 55-08.

However, noting the recorded recusals, he explained the significance of the contract in item 44-08 and advised that its award at this meeting is imperative.

At this time, General Counsel Hoffman confirmed his previously submitted Opinion and invoked the rule of "stern necessity" for Item 44-08, since a vote cannot be delayed due to the urgency of the contract award. Further, he cited that the Authority's Board is serving with less than the optimal number of members and opined that a vote by Commissioner Pocino would be required under all the given circumstances.

The Engineering items are as follows:

## <u>40-08</u>

In his memorandum dated February 14, 2008, concerning the recommendation to <u>Award a</u>

<u>Contract and Delegate Authority to Negotiate Terms of an Agreement – IdleAire Technologies</u>

<u>Corporation</u> – Truck Electrification System, Design, Construction, Operation and Maintenance,

New Jersey Turnpike Service Area 13 (Vince Lombardi), Funding: New Jersey Department of

Environmental Protection Grant.

Upon the approval of the Executive Director, the Engineering Department advertised for competitive proposals, consistent with the New Jersey Turnpike Authority's procurement law, for the installation of a truck electrification system at the Vince Lombardi Service Area in Ridgefield, Bergen County. The Turnpike Authority has received a grant from the New Jersey Department of Environmental Protection (NJDEP) in the amount of \$1,000,000 for the installation of the truck electrification system. The grant is part of \$2,100,000 in federal Clean Air Act funds that the NJDEP has received. The truck electrification system will be installed within approximately 70 existing truck parking spaces and will provide truckers with heating, ventilation and air conditioning, thereby eliminating the need for truck idling. Amenities such as cable television, internet access, movies and telephone service will also be available. The successful vendor must design, construct, operate and maintain the truck electrification system with the understanding that the Authority will not be providing any funding for the project. The funding required for the installation of the system will be fully paid by the NJDEP grant and the usage fees will be paid by

the truckers to the successful vendor. The successful vendor will enter into an agreement with the Authority for revenue sharing to compensate the Authority for the use of the Service Area 13 property. The Authority is authorized to enter into this agreement pursuant to N.J.S.A. 27:23-9, which provides, in pertinent part, that the Authority may enter into contracts with any person, partnership, association or corporation for the use of Authority property, for certain specified uses and for "any other purpose," and fix the terms, conditions and rents for such use.

Through a Request for Qualifications and subsequent Request for Proposals process, two vendors were prequalified and submitted Technical Proposals: IdleAir Technologies

Corporation of Knoxville, Tennessee and CabAire, L.L.C. of Enfield, Connecticut. A designated review committee examined and scored the two proposals for technical merit, resulting in IdleAire Technologies Corporation receiving the higher technical score consistent with the Authority's requirements. Prompt installation of the truck electrification system is a priority in order to ensure its use and operation no later than fall 2008 in time for the winter season.

Accordingly, to expedite the construction, it is recommended that the New Jersey

Turnpike Authority Commissioners authorize: (1) award of a contract to IdleAire Technologies

Corporation to install a truck electrification system at the Vince Lombardi Service Area and
release of NJDEP grant funds as payment therefor; (2) delegation of authority to the Law and
Engineering Departments to immediately negotiate the terms and conditions of an agreement
between IdleAire Technologies Corporation and the New Jersey Turnpike Authority contingent
upon passage of the Governor's Veto Period; and (3) execution by the Executive Director of the
final form of an agreement between IdleAire Technologies Corporation and the New Jersey

Turnpike Authority, together with any other necessary documentation, upon approval of the Law
Department and General Counsel. The Law and Engineering Departments concur in this
recommendation.

## <u>41-08</u>

In his memorandum dated February 12, 2008, concerning the recommendation to <u>Make</u>

Payment to Rutgers University for Structural Evaluation and Technical Support, Delaware

River Turnpike Bridge, Structure No. P0.00, PR 42919, Budget Code: 00-78-850-156508-07810001.

Authorization is requested to make payment to Rutgers University for technical support services required to investigate and analyze structural issues associated with newly constructed bridge decks on the Delaware River Turnpike Bridge, a major New Jersey Turnpike structure.

At the July 2005 Commission Meeting, the New Jersey Turnpike Authority awarded Contract No. R-1433 for improvements to the New Jersey side of the Delaware River Turnpike Bridge. The work included deck reconstruction with high performance concrete (HPC), shoulder area deck repairs, structural steel repairs, bearing replacements, lighting improvements, and roadway resurfacing.

During construction significant technical issues were encountered concerning the structural integrity of the bridge decks related to extensive cracking in the newly placed concrete. This condition compromised the safety of construction workers and the motoring public in the vicinity, which became an immediate concern. Accordingly, due to the emergent nature of this issue, the Authority requested Rutgers University to immediately mobilize and investigate these conditions. Rutgers University was requested to provide these services based on their unique set of capabilities, including their expertise and extensive experience with HPC bridge deck construction with the Authority, ability to perform sophisticated computer modeling of complex bridges like Delaware River Turnpike Bridge, and their laboratory testing facilities. During the investigation all construction activities were suspended until a determination could be made regarding cause and corrective actions required to address these issues. As a result of the Rutgers University investigation, which included strain gauging the superstructure and bridge decks, traffic data collection, controlled load testing, structural analysis, and laboratory testing of concrete samples, multiple revisions to the contract requirements were implemented. As a result of these new procedures, cracking in the subsequently placed bridge decks was significantly reduced. The cost for the aforementioned technical support services provided by Rutgers University is \$142,000. Given the need to quickly address this emergency, an exemption from the requirement to advertise these services, in accordance with N.J.S.A. 52:34-9.1 et seq. and N.J.A.C. 19:9-9-2.8, would be justified.

In addition, it is necessary to retain Rutgers University to provide follow-up technical support services associated with a final analysis of the completed bridge deck construction and for the development of revised construction procedures for similar future work pursuant to the issues encountered on Delaware River Turnpike Bridge. The cost for these services is \$43,000.

Accordingly, authorization is requested to pay Rutgers University in the amount not to exceed \$185,000, as outlined herein.

## <u>42-08</u>

In his memorandum dated February 13, 2008, concerning the recommendation to 

Execute Utility Order No. 1188-T for Contract No. T300.064 – Adesta, LLC – Ramp NWC 
Improvements at Turnpike Interchange 18W, Boroughs of Carlstadt and Ridgefield, Bergen 
County, Supplemental Capital Fund No. 08010005.

The construction of the Ramp NWC improvements, under Contract T300.064, will require the removal and relocation of existing Authority owned fiber optic facilities from the west side of the roadway to the east side. In addition, fiber optic connections will be required for new Variable Message Signs that will be installed and for the new E-ZPass gantries that will be constructed as part of the new tolling infrastructure on the ramp.

In this regard, the Authority will prepare a Utility Order to reimburse Adesta for the design and installation of new conduits, fiber optic cables and hand holes. This utility work needs to be

completed in advance of the Authority's construction contract in order to permit the construction of the proposed Ramp NWC Improvements.

A cost proposal for this Utility Order was provided by Adesta, LLC in the amount of \$450,600 based on the final improvements and known conditions at the time. The cost proposal is considered reasonable and its approval is recommended. Actual reimbursement to Adesta will be based on competitive bids received by Adesta for the construction components of the work.

It is, therefore, recommended that this Utility Order be authorized in the amount of \$450,600.

TPK Contract No. T200.018 – J. Fletcher Creamer & Son, Inc. and Joseph M. Sanzari, Inc., a

Joint Venture – Route 3, Route 120 Southbound to Route 3 Eastbound Ramp, New Jersey

Department of Transportation, Borough of East Rutherford, Bergen County, Supplemental Capital
Fund No. 08010012.

This contract will construct two structures to provide a new ramp from Route 120 Southbound to Route 3 Eastbound in the Borough of East Rutherford, Bergen County, New Jersey. In accordance with an agreement between the New Jersey Turnpike Authority (Authority) and the New Jersey Department of Transportation (NJDOT), this contract has been designed and will be constructed by the Authority on behalf of the NJDOT. Funds for this fully reimbursable contract have already been received by the Authority. This agreement was reached due to this Project's close proximity to the Authority's anticipated Contract No. T200.017 "Interchange 16W / Route 3 Ramps Improvements."

Ten proposals were received on February 14, 2008 for the above publicly advertised contract. The low bid, in the amount of \$12,967,000 may be compared to the Engineer's Estimate in the amount of \$13,000,650. The low bidder, J. Fletcher Creamer & Son, Inc. and Joseph M. Sanzari, Inc., a Joint Venture, has previously performed work for the Authority and is considered competent to complete this contract.

It is, therefore, recommended that Contract No. T200.018 be awarded to the low bidder, J. Fletcher Creamer & Son Inc. and Joseph M. Sanzari Inc., a Joint Venture, Hackensack, New Jersey, in the amount of \$12,967,000. The award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by this awardee pursuant to Public Law 2005, Chapter 51 and having no objection to same. Bids for this work were procured, and the authorization being sought is to award this contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1 and N.J.A.C. 19:9-2.2. The General Consultant, HNTB Corporation, concurs with this recommendation.

Reviewed by the Law Director and available funds certified by the Finance Director where appropriate; the Executive Director certified the recommendations for consideration.

Supplement Nos. 1, 2 and 3, in the total amount of \$2,980,000.00, provided for conversion of design from Metric units to English units, design reclassification of ramps, alternative study of ramp connection from Parkway southbound to I-78 westbound, pavement restoration of I-78, seismic analysis, environmental sampling and revisions to the Interstate Access Approval Document.

Supplement No. 4 will compensate Gannett Fleming to perform post-design construction support services (CSS) for Parkway Interchange 142 Improvements. The construction contract is being awarded by NJDOT. Accordingly, because this is an NJDOT project, post-design CSS are supplemental to the original OPS. In general, the CSS consist of responses to pre-bid contractor

questions, attendance at various meetings, approval or certification of working drawings, responses to post-award Requests for Information (RFI), performing construction inspection services for the Union Toll Facility Building and other related services. Award of this supplement is in accordance with the December 2007 cost sharing agreement between the State of New Jersey and the New Jersey Turnpike Authority (NJTA) that requires the NJTA to provide funds to the designer for construction engineering services in advance of the construction award. The funds for this supplement are to be applied toward the NJTA's fiscal year 2008 total share of \$10,163,000.00.

The fee of \$5,297,453.60 submitted by Gannett Fleming Inc. for these additional services has been reviewed, negotiated and is considered fair and reasonable for the services to be provided.

It is, therefore, recommended that Supplement No. 4 to GSP OPS No. 134-736D-2 be issued to Gannett Fleming Inc. in the amount of \$5,297,453.60 with compensation on the same basis as the original OPS. Order for Professional Services (OPS) No. T3041 was issued at the July 2005

Commission Meeting in the amount of \$2,005,000 to provide construction supervision services for Contract No. R-1433. This contract provides for improvements to the New Jersey side of the Delaware River Turnpike Bridge, a major New Jersey Turnpike structure. The work includes deck reconstruction, shoulder areas, deck and structural steel repairs, bearing replacement, lighting improvements and roadway resurfacing.

Supplement A will compensate the HNTB Corporation for additional unanticipated professional services to provide construction inspection services required for the extended contract duration, as well as additional material testing costs, which are a direct expense. The contract completion date is being extended as the result of a work suspension initiated by the New Jersey Turnpike Authority (NJTA) and for the additional time required by the contractor to construct scheduled improvements under the modified contract requirements implemented shortly thereafter.

The contract work was suspended to allow for the immediate mobilization of the Design Engineer and Rutgers University, on an emergency basis, to investigate structural issues with the recently poured new concrete bridge decks. The NJTA requested Rutgers University's participation based on their expertise and considerable past experience with high performance concrete bridge deck construction with the NJTA and their ability to perform sophisticated structural analysis of this major Turnpike bridge structure. Following the investigating team's analysis, recommendations were implemented to mitigate future structural issues, which included significant revisions to the contract requirements. These revisions added time restrictions to key operations employed by the contractor for the preparation and placement of the new concrete bridge decks. The effect of these provisions was to reduce the contractor's allowable working hours, which in turn required more working days for constructing the remaining contract work.

Supplement A also includes additional unanticipated professional services to assist the NJTA in the review, analysis and negotiations with the contractor in the settlement of their request for additional compensation as they relate to the aforementioned issues. OPS No.T3041 provided for construction supervision services for 22 months. As a result of the extended contract duration, supervision of construction services will be extended by 9 months.

The fee of \$355,000 submitted by HNTB Corporation for these unexpected additional professional services and direct expense costs has been reviewed, negotiated and is considered fair and reasonable for the services to be provided.

It is, therefore, recommended that OPS No. T3041A be issued to HNTB Corporation in the amount of \$355,000 with compensation on the same basis as the original OPS. The addition of this amount increases the total authorized fee from \$2,005,000 to \$2,360,000. The original contract was procured pursuant to N.J.S.A. 52:34-9.1 et seq. and N.J.S.A. 19:9-2.8.

This contract provides for the replacement of existing lighting facilities with new high mast lighting and associated incidental work from milepost 117.9 to milepost 122.0 along the Turnpike's I-95 northern terminus in Bergen County, New Jersey.

Supplement A will provide additional professional services required as a result of a compensable delay experienced on Contract No. R-1318B. The project duration was extended by approximately five months as a result of a Change of Plan issued to address several maintenance and protection of traffic issues, which reduced the contractor's work area and the allowable lane closing hours.

The fee of \$32,000 submitted by Kupper Associates for these additional services has been reviewed, and is considered fair and reasonable for the additional services to be provided.

Order for Professional Services (OPS) No. A3083 was issued at the March 28, 2006 Commission Meeting in the amount of \$1,300,000 to provide construction management and inspection services for the new Turnpike Authority Traffic Management Center, with an anticipated completion date of March 31, 2007.

Subsequent to issuing the OPS, the Authority modified the project approach and made significant changes to the contract documents, as well as adding a third contract to the project that was not anticipated at the time the original scope of services for OPS No. A3083 were defined. These changes will increase the project duration by about one year, resulting in the need for additional professional services to properly supervise the construction.

Supplement A will compensate Hill International Inc. for providing additional construction management and inspection services required to cover the extended construction duration of approximately twelve months. The anticipated completion date is March 31, 2008.

Hill International submitted a scope and fee for these additional services which has been reviewed and negotiated. A fee of \$280,000 is considered fair and reasonable for the additional services to be provided.

It is, therefore, recommended that OPS No. A3083A be issued to Hill International in the amount of \$280,000, with compensation on the same basis as the original OPS. The addition of this amount increases the total authorized fee from \$1,300,000 to \$1,580,000. The original contract was procured pursuant to N.J.S.A. 52:34-9.1 et seg. and N.J.S.A. 19:9-2.8.

a Type 3 Change Order, Change Order No. 2 for Contract No. T200.058 – Crisdel Group Inc.

- Resurfacing, Turnpike Milepost 74 to 122, Maintenance Reserve Fund No. 03010002.

The purpose of this Change Order No. 2, Type 3 - is to engage Crisdel Group Inc. to perform additional construction activities within the limits of the referenced contract, but considered beyond their current scope of work.

By way of background, in early December 2007, the Turnpike Maintenance Department responded to a call-out in which a sink hole had occurred in the left travel lane of the southbound inner roadway at approximately milepost 121 in Bergen County on the I-95 section of the Turnpike. Immediate repairs were made and the situation was monitored. Over the next few days, the Maintenance Department was required to place additional asphalt as settlement occurred. It was determined that the sink hole is the result of a failed drainage pipe located in the median under the concrete barrier.

On an emergent basis it was necessary to remove traffic from the vicinity of the sink hole by constructing a temporary traffic shift and placing traffic on the shoulder. On December 13, 2007 Crisdel Group was mobilized for this effort as Contract No. T200.058 provides bid line items for the majority of the work required to install the traffic shift consisting of milling, resurfacing and line striping. In addition, they installed temporary concrete construction barrier and traffic control devices to move traffic away from the affected area.

It will be necessary to reconstruct the drainage pipe in the median in order to make permanent repairs. The Engineering Department engaged Stantec through its on-call services engineering OPS to evaluate various repair options and prepare plans to construct the repairs.

In order to restore traffic to its normal configuration as soon as possible and to insure the motoring public's safety, the Engineering Department recommends that a Type 3 Change Order be issued to Crisdel Group Inc. to construct the repairs immediately upon finalization of the design and subject to weather. It is anticipated that this work will require the removal of portions of the existing concrete median barrier; construction of approximately 300 lineal feet of new drainage pipe, inlets and appurtenances; construction of new concrete median barrier; construction of embankment, pavement, line striping; and other miscellaneous items of work. Crisdell is recommended to perform this work for the following reasons: First, the repairs are within the limits of their current contract and thus can be scheduled without conflict with other contractors. Second, Crisdel was able to quickly and effectively mobilize and perform the emergent traffic shift work in order to safeguard the traveling public by placing the traffic on the shoulder. Third, they are well equipped and prequalified with the Authority to perform this type of construction and have performed other work for the Authority on short notice on several occasions in the past. And lastly, we have found them to be fair, reasonable, accommodating to the Authority's needs, and extremely responsive.

Upon finalization of the design and preparation of the Change of Plan, Crisdel Group, Inc. will be requested to provide a price proposal to perform the work. While an Engineers Estimate is not yet available as the design has not been finalized, preliminary evaluation has determined that the cost is anticipated to be in the magnitude of approximately \$700,000.

It is, therefore, requested that a Type 3 Change Order, Change Order 2 be issued to Contract No. T200.058 to perform the immediate repairs outlined above, upon completion of final design and price negotiation with Crisdel Group Inc. as necessary.

Given the use of the P-Card, it is necessary to adopt policies and procedures for use by Authority personnel ("P-Card Policy"). The P-Card Policy will, among other things, detail cardholder eligibility and responsibilities; P-Card limits; prohibited goods and services; purchasing restrictions; and approval processes and actions which will be taken in event of violations of the policies and procedures.
