Instructions to Designers and Consultants





Description of Change

It is recommended to clarify the Appendix of the NJTA CAD Manual which lists the LEVEL names and settings for project file setup. The tables provided in the manual do not coincide with the CSV resource files from the NJTA website. The level naming format (with color & weight assignments) presented on pages 22 to 35 deviates significantly from the text of Section 3 in the CAD Manual which describes the format contained within the CSV files. The Appendix appears to be based on the previous CAD manual and should be updated with the current level structure from the resource files to reflect the preference of the Authority.

Reason for Change

The content of the Appendix of the CAD Manual should reflect the content of the resource files to avoid confusion amongst users. Presently, the manual contradicts the level structure imported through the CSV files and may result in application of the original (or alternative) level conventions if not confirmed through the NJTA Project Manager. The correct naming and element assignments should be presented in the Appendix to coordinate with that of the supplied NJTA resource files.
