## Responses to Inquiries Request for Expressions of Interest

- 1. **Inquiry:** Could you clarify the maximum EOI page limit. On page 3 of the RFEOI it states that the LOI is limited to 7 pages, page 5 allows a max. of 7 resumes which would result in a 14 page limited, however page 6 limits the total number of pages to 11.
  - **Response:** The Letter of Interest is limited to 7 pages, and a maximum of 7 resumes is permitted, which would result in a 14 page EOI.
- 2. **Inquiry:** According to Page 6, EOIs are limited to 11 pages. However, according to page 3 we are allowed 7 pages for the letter of interest and per page 5, 7 resumes, for a total of allowed pages of 14. Please confirm that we are allowed 14 pages, not 11.
  - **Response:** The Letter of Interest is limited to 7 pages, and a maximum of 7 resumes is permitted, which would result in a 14 page EOI.
- 3. Inquiry: Please clarify the work intended for Structure No. 117.16, Overpeck Creek Causeway. Since it is not a navigable waterway, lighting is not required, nor does it have any type of fender system. Are the intended repairs related to the timber tide gates and steel sheeting?
  - **Response:** The consultant will be required to inspect the elements within the waterway and recommend limits of repairs that are required.
- 4. **Inquiry:** Is the latest Bridge Inspection Report for Structure No. 127.2N & 127.2S (GSP over Raritan River) and the "nocturnal inspection" reports for all structures available? They were not included in the materials/documents available to download from NJTA's website.
  - **Response:** The file names for the Bridge Inspection Reports for Structure No. 127.2N &127.2S located on the ftp website are "127.2S 2015 Biennial Inspection Report Final.pdf" and "127.2N 2015 Biennial Inspection Report Final.pdf". In one location in the RFP it is called out as 7 and in another location it is indicated as 11. Response: The Letter of Interest is limited to 7 pages, and a maximum of 7 resumes is permitted, which would result in a 14 page EOI. 6. Inquiry: Please clarify what items are to be included as part of the page limit count? Response: The Letter of Interest is limited to 7 pages, and a maximum of 7 resumes is permitted, which would result in a 14 page EOI. What items are excluded from the EOI page limit count.
