In a memorandum dated October 9, 2018, <u>Authorization to Amend the State</u>

<u>Transportation Projects Funding Agreement,</u> was approved.

At its June 28, 2016 meeting, under Agenda Item Item No. 240-06-2016, the Board of Commissioners authorized the Executive Director to enter into a State Transportation Projects Funding Agreement ("the Funding Agreement") between the New Jersey Turnpike Authority ("the Authority") and the Treasurer of the State of New Jersey. Under the terms of this agreement, the Authority makes payments to the State of New Jersey to be used for statewide transportation purposes for a five-year period which began on July 1, 2016 and ends on June 30, 2021.

The Authority has made annual payments, payable quarterly, of \$204 million in state fiscal years 2017 and 2018, consistent with the terms of the Funding Agreement. In addition, the Funding Agreement obligates the Authority to make payments totaling a lesser amount of only \$129 million per year in state fiscal years 2019, 2020 and 2021. The total payments over the five-year period are \$797 million, nearly half the total of the payments under the previous State Transportation Projects Funding Agreement which covered state fiscal years 2012 – 2016.

The Treasurer has asked the Authority to increase its state fiscal 2019 payment by \$25 million, bringing the total to \$154 million for the year. The additional \$25 million will be payable in two payments of \$12.5 million each on 3/31/19 and 6/30/19. The payments in state fiscal year 2020 and 2021 will remain the same as in the current Funding Agreement at \$129 million each year.

With the proposed amendment, the total payments over the five-year period will be increased by \$25 million to \$822 million. Payments will continue to only be made from legally available revenues in the General Reserve Fund, and are subordinate to the payments required to be made to the Authority's bondholders and all other payments required to be made under the Authority's General Bond Resolution. The additional \$25 million payment in state fiscal 2019 has been included in the Authority's 2019 Annual Budget.

Based on the above, approval of the Authorization to Amend the State Transportation Projects Funding Agreement is requested.

T3665 and T3666, New Jersey Turnpike, Greenman-Pedersen, Inc. - OPS No. T3665, Michael Baker International, Inc. - OPS No. T3666, Order for Professional Services No. T3665, Design Services for Contract No. T100.465, Bridge Repairs and Resurfacing, Milepost 92 to 122, and the Newark Bay-Hudson County Extension (2020), RM-143742, Budget Code: 030C10001E, Funding allocation: \$1,310,000.00 FY 2019, \$500,000.00 FY 2020, Amount: \$1,810,000.00, and Order for Professional Services No. T3666, Design Services for Contract No. T100.466, Bridge Repairs and Resurfacing, Milepost 0 to 92, and the Pearl Harbor Memorial Turnpike Extension (2020), Budget Code: 030C10001E, RM-142743 Funding Allocation: \$800,000.00 FY 2019, \$405,000.00 FY 2020, Amount: \$1,205,000.00, was approved.

Through this single procurement process, the Authority will select two consultants to furnish design services and prepare construction contract documents for the annual bridge deck and miscellaneous structural repair contracts for 2020, which will address the northern and southern portions on the Turnpike.

The design services associated with OPS No. T3665 provides for bridge inspection, condition evaluation and preparation of contract documents for Bridge Deck Repairs, Resurfacing and Miscellaneous Structural Repairs on the northern portion of the Turnpike.

The design services associated with OPS No. T3666 provides for bridge inspection, condition evaluation and preparation of contract documents for Bridge Deck Repairs, Resurfacing and Miscellaneous Structural Repairs on the southern portion of the Turnpike.

These assignments are classified as "Simple Projects" since the scopes of work are clearly defined and not likely to change during the course of the project, and the cost of each is less than \$2,000,000.00. The Solicitation for Expressions of Interest (EOIs) was posted on the Authority's website and 46 engineering firms were prequalified and eligible under Profile Codes: A092 – Bridges: Miscellaneous Repairs and A093 – Bridges: Deck Replacement and Rehabilitation. Three firms submitted EOIs by the closing date of August 7, 2018.

The scoring of the EOIs by the Review Committee resulted in the following order of ranking: 1) Greenman-Pedersen, Inc.; 2) Michael Baker International, Inc. and 3) Arora and Associates, P.C. These three firms were requested to submit sealed Fee Proposals. Fee Proposals submitted by the three firms have been reviewed. A review of the fee proposal of the highest technically ranked firm, Greenman-Pedersen, Inc., for OPS No. T3665 (their preferred OPS) was negotiated which resulted in a reduction in their fee proposal. Subsequently, a review of the fee proposal of the second highest technically ranked firm, Michael Baker International, Inc. for OPS No. T3666 resulted in acceptance of their original fee proposal. Both fees are considered to be fair and reasonable for the services to be provided.

It is, therefore, recommended that Order for Professional Services No. T3665 to provide Design Services for Contract No. T100.465 be issued to the firm of Greenman-Pedersen, Inc., of Lebanon, NJ, not to exceed the amount of \$1,810,000.00 allocated as follows: \$1,310,000.00 in FY 2019 and \$500,000.00 in FY 2020. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.80 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses.

It is further recommended that Order for Professional Services No. T3666 to provide Design Services for Contract No. T100.466 be issued to the firm of Michael Baker International, Inc. of Hamilton, NJ, not to exceed the amount of \$1,205,000.00 allocated as follows: \$800,000.00 in FY 2019 and \$405,000.00 in FY 2020. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.68 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses.

Through this single procurement process, the Authority will select two consultants to furnish engineering services for bridge inspections on the Garden State Parkway.

The engineering services associated with OPS No. P3670 will include inspection of 139 bridges located in the northern region of the Garden State Parkway and OPS No. P3671 will include inspection of 138 bridges located in the southern region of the Garden State Parkway. Both OPS' include FHWA Structure Inventory and Appraisal (SI&A) form updates, FHWA Element Level Inspection data collection, and preparation of bridge inspection reports.

These assignments are classified as "Simple Projects" since the scopes of work are clearly defined and not likely to change during the course of the project, and the cost of each is less than \$2,000,000.00. The Solicitation for Expressions of Interest (EOIs) was posted on the Authority's website and 31 engineering firms were prequalified and eligible under Profile Code: D280C – Bridges, NBIS Program, Complex. Eight firms submitted EOIs by the closing date of August 23, 2018.

The scoring of the EOIs by the Review Committee resulted in the following order of ranking: 1) Cherry, Weber & Associates, P.C.; 2) Pickering, Corts & Summerson, Inc. and 3) KS Engineers, P.C. These three firms were requested to submit sealed Fee Proposals. Fee Proposals submitted by the three highest ranking firms have been reviewed. A review of the fee proposal of the highest technically ranked firm, Cherry, Weber & Associates, P.C., for OPS No. P3671 (their preferred OPS) was negotiated, which resulted in an increase in their fee to accommodate the inspection and load rating of an additional bridge, which was recently added to the Authority's inventory after issuance of the RFEOI. Subsequently, a review of the fee proposal of the second highest technically ranked firm, Pickering, Corts & Summerson, Inc. for OPS No. P3670 was negotiated, which resulted in a reduction in their fee proposal. Both fees are considered to be fair and reasonable for the services to be provided.

It is, therefore, recommended that Order for Professional Services No. P3670 be issued to the firm of Pickering, Corts & Summerson, Inc., of Phillipsburg, NJ, not to exceed the amount of \$845,000.00 allocated as follows: \$765,000.00 in FY 2019 and \$80,000.00 in FY 2020. This

amount includes reimbursement of direct salaries times a maximum multiplier of 2.80 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses.

It is further recommended that Order for Professional Services No. P3671 be issued to the firm of Cherry, Weber & Associates, P.C. of Freehold, NJ, not to exceed the amount of \$719,000.00 allocated as follows: \$645,000.00 in FY 2019 and \$74,000.00 in FY 2020. This amount includes reimbursement of direct salaries times a maximum multiplier of 2.73 to cover the cost of fringe benefits, overhead and profit, plus authorized direct non-salary expenses.

The issuance of these OPS' are contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. These professional services were procured, and the recommended firm was selected, in accordance with N.J.S.A. 52:34-9.1, et seq., N.J.S.A. 27:23-6.1 of the Authority's enabling legislation, N.J.A.C. 19:9-2.8, promulgated pursuant thereto, and Executive Order No. 37 (Corzine 2006).

In a document dated October 5, 2018, Recommendation to Issue Supplement C to Order for Professional Services No. A3458, Garden State Parkway and New Jersey Turnpike, Michael Baker Jr., Inc., Supervision of Construction Services for Contract No. T500.192, Replacement of Maintenance Building at Turnpike District 6 Yard, Milepost E111.50, Contract No. T500.272 – Construction of Troop "D" Newark Station, Turnpike Milepost 104 SB, Contract No. A500.274 – Construction of Troop "D" Moorestown Station, Turnpike Milepost 37 NB and Galloway Station, Parkway Milepost 42, Budget Code: 39005013, RM-143748, Original OPS Amount: \$6,500,000.00, Amount of Supplement A: \$2,030,000.00. Amount of Supplement B: \$598,000.00, Amount of Supplement C: \$250,000.00, Revised OPS Amount: \$9,378,000.00, was approved.

This Order for Professional Services was issued at the December 2012 Commission Meeting in the amount of \$6,500,000.00 to provide supervision of construction services for Contract Nos. T500.192, T500.272 and A500.274 to ensure that the referenced contracts were constructed in accordance with the Contract Plans and Specifications.

Supplement A authorized Michael Baker Jr., Inc. to provide additional supervision of construction services for the various time extensions to each contract, specifically approximately 1.5 years beyond the original scope of Contract No. T500.192 (Secaucus) and over one year beyond the original scope of Contract No. A500.274 (Moorsetown/Galloway). Furthermore, additional supervision of construction services were required due to the termination of Contract No. T500.272 (Newark) and the resulting rebid and award of Contract No. T500.395 (Newark rebid).

Supplement B provided for additional construction supervision services for various time extensions to two contracts. Contract No. T500.192 (Secaucus) required a nine month extension and support in resolution of contractor claims and outstanding liquidated damages. Contract No. T500.395 (Newark rebid) required a one year extension due to unforeseen site conditions and contractor delays in structural steel erection.

Supplement C will provide for six months of additional construction supervision services for Contract No. T500.395 (Newark rebid) due to significant delays with PSE&G in obtaining permanent power. At the issuance of Supplement B, the new building was to be energized on September 12, 2017. The actual date was June 20, 2018. With the building energized, commissioning and building inspections could then begin. Michael Baker Jr., Inc. has reduced staff to minimize additional costs.

It is, therefore, recommended that Supplement C to Order for Professional Services No. A3458 be issued to Michael Baker Jr., Inc. not to exceed the amount of \$250,000.00 with compensation on the same basis as the original Order for Professional Services. The addition of this amount increases the total authorized fee from \$9,128,000.00 to \$9,378,000.00. The original contract was procured pursuant N.J.S.A. 52:34-9.1 et seq. and N.J.A.C. 19:9-2.8.

An Evaluation Committee (the "Committee"), established by the Executive Director, consisted of personnel from the Law, Engineering and Finance Departments. In addition, the Director of the Procurement and Materials Management Department and the Authority's Risk Management Consultant served as non-voting members of the Committee. The Committee reviewed the written proposals based on the criteria set forth in the RFP and scored each firm individually. Based on the Committee's review of the proposals, the Committee invited representatives from the two top-ranked firms, Marsh and Willis, to make oral presentations and provide best and final offers ("BAFOs"). Based upon the written and oral presentations, the

Committee prepared a report that detailed the evaluation process and set forth its findings and recommendation.

The Committee found that both Marsh and Willis demonstrated high levels of experience and were responsive to the RFP Scope of Services. Each firm provided professional and comprehensive oral presentations and both met or exceeded the requirements for the project team and for servicing public sector clients. The Committee, however, concluded that the proposal submitted by Marsh demonstrated the most benefit to the Authority, and thus received the highest score. Marsh submitted a proposal that evidenced a complete and in-depth understanding of the Authority's property risk profile. In addition, Marsh's proposed project team included a Client Executive, a Senior Client Advisor and the Property Practice Leader, all with significant years of experience. In addition, the proposed Property Claims Advocate, Placement Specialist and Client Advisor had solid experience in the insurance field. The Committee was impressed with the project team's experience in providing similar services to other public entities which was well demonstrated in their written proposal, as was their understanding of the tasks required in providing property broker services to the Authority. Marsh submitted a final fee proposal of \$135,000 for each year of the term, including renewal years, if the Authority opts to extend the contract. The Committee found that Marsh scored the highest on the qualitative criteria and proposed the second lowest fees. The Committee recommended Marsh for the underlying brokerage services.

This professional services procurement was conducted in accordance with *N.J.S.A.* 27:23-6.1, *N.J.A.C.* 19:9-2.1(b), Executive Order No. 37 (Corzine 2006), and Executive Order No. 26 (Whitman 1994). An Evaluation Committee ("Committee"), established by the Executive Director, consisted of the Deputy Executive Director, Director of Human Resources, Director of Internal Audit and HR Benefits Manager. The Assistant Director of Law and the Director of Procurement and Materials Management served as non-voting members of the Committee. The Committee reviewed the written Qualifications and invited representatives from the following six (6) top-ranked firms, namely: Capehart Scatchard, P.A; Chasan Lamparello Mallon & Cappuzzo, PC; Florio Kenny Raval, L.L.P.; Gluck Walrath LLP; Shain Schaffer PC and Waters, McPherson, McNeill, P.C. The RFQ stated clearly that the number of firms receiving specific awards would be determined by the Committee after the completion of its evaluation of all the Responses received. Set hourly rates for partners (\$200), associates (\$150) and legal assistants (\$90) were set forth in the RFQ for Authority Counsel (Conflicts). For Special Counsel-Collections, fees were set forth in the RFQ that included a contingent fee basis for collection work as well as hourly rates for appellate work and appeals.

The Committee reviewed the Responses submitted. This review was extensive, incorporating the general information regarding each firm's profile and experience, as well as the qualifications and experience for each firm in the individual practice area(s) for which they had responded. 234-10-2018

In a memorandum dated October 12, 2018, <u>Authorization to Adopt the 2019 Annual Budget</u>, was approved.

Attached for your consideration is the 2019 Annual Budget, which includes the Authority's Revenue Budget, Operating Expense Budget, Debt Service Fund Budget, Maintenance Reserve Fund Budget, Special Project Reserve Fund Budget, Supplemental Capital Budget, and General Reserve Budget.

In 2019, the Authority will continue its commitment to prudently manage the finances and operations of the Authority to provide its customers with a safe, efficient, innovative and resilient roadway system. The 2019 Annual Budget provides sufficient funding to meet these Authority goals for its legacy roadway systems as well as the added lane miles from the widenings of the New Jersey Turnpike ("Turnpike") and Garden State Parkway ("Parkway"). The roadway widening program was completed in 2018 with the Garden State Parkway widening from Mileposts 35 to 42 opened earlier this year. The Authority continues to focus on state of good repair, and continues to increase its Maintenance Department staff to meet the demands of the added roadway capacity, while controlling headcount in administrative departments through technology efficiencies. As part of the Authority's commitment to safety, the 2019 Annual Budget provides for potential additional State Troopers to patrol the roadways.

The Authority arrived at the 2019 Annual Budget by engaging in a comprehensive budget preparation process, which began several months ago and directed departmental managers to think strategically as well as identify all opportunities to achieve operational efficiencies. With a critical eye, directors reviewed their respective departmental budgets and evaluated all positions and line item expenditures, as well as all proposed project budgets.

The proposed 2019 Annual Budget accomplishes the following:

- (1) Provides sufficient funding for operating expenses to operate and maintain the legacy roadway system as well as the increased capacity added by the Turnpike and Parkway widening projects. The 2019 Annual Budget also provides funding to maintain the Authority's commitment to safety, while controlling operating expenses in all other functional areas;
- (2) Provides for debt service payments of nearly \$832,823,000, and includes projected interest payments on the final new money bond issuance expected later in 2018. This new money issuance of approximately \$525,000,000 will complete the funding of the \$7 Billion Capital Improvement Program;
- (3) Provides more than \$376,000,000 of spending on Maintenance Reserve, Special Project Reserve, and Supplemental Capital projects, an increase of 12% from 2018;
- (4) Maintains a minimum unencumbered General Reserve Fund balance in excess of \$175,000,000 as required by Board policy; and

(5) Meets General Bond Resolution financial covenants, Board adopted financial targets, and all other financial obligations without the need for a toll increase.

The proposed 2019 Revenue Budget of \$1,833,405,000 includes a projected increase in toll revenue of 0.6% on the Turnpike and 0.2% on the Parkway as compared to the Amended 2018 Revenue Budget. The 2019 toll revenue budget was derived from a report done by the Authority's traffic engineering consultant in September 2018. Toll revenue projections for 2019 include the full year impacts of the re-opening of the Pulaski Skyway and anticipate that motorists who previously used that toll-free facility prior to its closing would stop traveling the Turnpike and return to the Pulaski Skyway upon its re-opening. The new toll revenue projections are about \$10,000,000 higher each year than the previous projections contained in the prior traffic engineering consultant report. E-ZPass fees are budgeted to increase by about \$1,500,000, or 2.0%, reflecting normal growth as New Jersey E-ZPass accounts continue to increase. Interest income is expected to increase by \$3,000,000, or 13.6%, as stable interest rates and invested balances are projected compared to 2018 actual results. The 2018 actual results have exceeded budget and thus are causing a budget to budget increase. Miscellaneous revenue is expected to decrease by about \$6,000,000, or 35.3% as the Authority received advance insurance payments from the Delaware River Turnpike Bridge claim during 2018 which are not expected to reoccur for budget purposes. Concession revenue is budgeted to decline by \$6,000,000, or 15.0% due to the closure of service areas for remodeling, and an adjustment to budget as 2018 revenue is under budget primarily due to lower gas sales.

The proposed 2019 Operating Expense Budget of \$582,071,000 represents an \$11,120,000 million, or 1.9%, increase as compared to the Amended 2018 Operating Expense Budget. Key cost factors in the 2019 Operating Expense Budget include the following:

- increased medical benefit costs of \$6,700,000 based upon estimated usage and the projected medical inflation rate;
- increased salaries and wages of \$4,000,000 reflecting an additional 28 net new positions, contractual step increases for union employees and potential negotiated wage increases:
- increased maintenance costs of \$3,300,000 primarily for drainage and lighting repairs on the roadways;
- increased electronic toll collection costs of \$2,000,000 related to higher credit card fees and transaction processing and collection costs driven by increased volumes;
- increased insurance costs of \$1,100,000 due to expected premium increases for general liability and property insurance as insured values increase;
- increased State Police costs of \$1,000,000 due to 23 anticipated additional troopers assigned to the roadways as well as higher wages and pension costs for existing



troopers;

Although it must absorb these significant and necessary cost increases, the Authority is able to propose a 2019 Operating Expense Budget with an increase of only \$11,120,000. This modest increase was achieved because the Authority is expected to achieve savings in several areas including lower transponder expenses as a significant tag swap program will be completed in mid-2019, savings from new prescription drug, dental and vision benefit contracts, the elimination of the summer season manual toll collector program through reassignment of existing staff, and lower equipment maintenance costs from the elimination of ACM machines on the Garden State Parkway mainline barriers and the installation of new toll collection equipment at various locations on both roads.

The 2019 Annual Budget also includes the 2019 Debt Service Fund Budget of \$832,823,000, which includes principal and interest payments payable through revenues on the Authority's currently outstanding bonds. The 2019 Debt Service Fund Budget is increasing by about \$37,178,000, or 4.7%, as compared to the Amended 2018 budget mainly due to a full year of interests' costs budgeted at 5% on the projected \$525 million new money borrowing expected to occur in late 2018, as well as higher principal payments on existing bonds. Debt service remains the single largest spending component of the annual budget, at 46% in 2019.

Also included is the 2019 Maintenance Reserve Fund Budget totaling \$185,025,000 which primarily supports spending for the maintenance and resurfacing of roadway and bridges on the Turnpike and Parkway. The 2019 Maintenance Reserve Fund Budget includes all estimated 2018 carry-over projects as well as new work to be completed in 2019. The budget is increasing by about 38% compared to 2018, and includes additional funding for resurfacing as well as roadway lighting, drainage structure and concrete barrier repairs. It should be noted that roadway resurfacing funding from the Maintenance Reserve Fund is increasing in 2019 by about 72% to about \$68,000,000. The increase is necessary to keep the assets in a state of good repair according to maintenance cycles recommended by the Authority's General Consulting Engineer, HNTB Corporation ("HNTB").

The 2019 Special Project Reserve Fund Budget totaling \$65,149,000 includes all estimated 2018 carry-over projects and is increasing by about 7% compared to the amended 2018 budget. The 2019 Special Project Reserve Fund Budget provides spending for the Authority's scheduled major fleet augmentation, which is the Authority's existing scheduled fleet replacement program, as well as funds for bridge and structure inspections, and facility improvements, among other necessary projects.

The 2019 Supplemental Capital Budget totaling \$126,520,000 is also part of the 2019 Annual Budget. This budget includes all estimated 2018 carry-over projects, and provides about \$44,500,000 for new projects. The 2019 Supplemental Capital Budget includes funding to continue several necessary multi-year projects including the replacement of the toll collection

equipment on both roadways and the reconstruction of the Westerly Hackensack River Bridge piers on the New Jersey Turnpike.

Finally, the 2019 General Reserve Budget totals \$256,845,000 and includes the Authority's contractual payments due in calendar 2019 under the Transportation Trust Fund Agreement and State Transportation Projects Funding Agreement (2016-2021) including the \$25 million additional payment from the proposed amendment to the contract, extraordinary severe weather costs, and reserves for self-insured liability claims and other postemployment benefit costs. For the first time, the General Reserve Budget includes \$25 million of funds to be transferred to the Construction Fund to finance the reconstruction of three bridges over the Passaic River. The \$25 million in funding was generated from debt service savings from refinancing Authority bonds during 2017.

The Authority's proposed 2019 Annual Budget provides the necessary Operating Expense Budget to maintain the widened roadways and existing facilities, cover additional technology enhancements, and fund ongoing safety initiatives including an increased State Police presence, while controlling costs in all functional areas. The 2019 Annual Budget also adequately funds the Authority's other project and reserve accounts without the need for a toll increase. The proposed 2019 Annual Budget allows the Authority to meet all General Bond Resolution financial covenants and is consistent with the Authority's Financial Management Principles and Guidelines.

It is therefore recommended that the Authority adopt the attached 2019 Annual Budget. The Authority's General Consulting Engineer, HNTB, concurs with this recommendation.

Certification 713 (c), was approved.

Under the provisions of Section 713 (c) of the Turnpike Revenue Bond Resolution adopted by the Authority on August 20, 1991 as amended and supplemented (the "Resolution"), the Authority, on or before December 1 in each year, shall complete a review of its financial condition for the purpose of estimating whether the Net Revenues (as such term is defined in the Resolution) for such year and for the next succeeding year will be sufficient to comply with subsection (b) of Section 713 of the Resolution and shall by resolution make a determination with respect thereto. A copy of such resolution, certified by an Authorized Officer of the Authority, together with a certificate of such Authorized Officer setting forth a reasonably detailed statement of the actual and estimated receipts and the payments to be made therefrom for such year, shall be filed with the Trustees on or before December 20.

If it fails to meet the requirements of Section 713 (b) of the Resolution, the Authority shall have its Traffic Engineers conduct a study for the purpose of recommending a schedule of tolls

which will provide the necessary revenues to meet the requirements.

The undersigned has completed the review of the financial condition of the Authority for the years 2018 and 2019. The Authority is now in a position to make the determination showing that the requirements of Section 713 (b) of the Resolution will be met in the years 2018 and 2019.

As the basis for your review, I have prepared the following schedules relative to the two years under review, 2018 and 2019, which accompany this memorandum.

Schedule A

This schedule contains a Resolution which states that a review has been made of the Authority's financial condition for the purpose of estimating whether the tolls, revenues, fees, charges, rents and other income and receipts from the operation of the New Jersey Turnpike and the Garden State Parkway during 2018 and 2019, including investment income treated as revenues for each year, will be sufficient to provide all of the payments and meet all other requirements as specified in Section 713 (b) of the Resolution.

Schedules B and C

These schedules set forth calculations relative to 2018's revenue requirements. Specifically, the schedule provides actual revenue through September 30, 2018 and projected revenue for the balance of the year (October-December 2018).

Schedules D and G

These schedules set forth figures to support the certification under Section 713(c) of the Resolution demonstrating that in each calendar year "Net Revenues shall at least equal the Net Revenue Requirement for such year" as required by Section 713(b) of the Resolution. Under Section 101 of said Resolution, Net Revenues are defined as "... for any calendar year or other period of time, the Pledged Revenues during such year or period less the amounts of the Operating Expenses for such year or period." The Net Revenue Requirement means with respect to any period of time, "an amount equal to the greater of

(i) The Sum of the Aggregate Debt Service, Maintenance Reserve Payments, Special Project Reserve Payments, and payments, if any, to the Charges Fund for such period

or

(ii) 1.20 Times the Aggregate Debt Service for such period (excluding, for purposes of clause (ii) only, any payment due and payable by the Authority under a Qualified Swap upon an early termination thereof)."

Schedules E and F

These schedules set forth calculations relative to 2019's financial projections and estimated revenue provisions.

Based upon a review of the financial condition of the Authority, it is estimated that Net Revenues (as such term is defined in the Resolution) for 2018 and 2019 will be sufficient to

comply with Section 713 (b) of the Resolution.

The Net Revenue Requirement means with respect to any period of time, "an amount equal to the greater of (i) the sum of Aggregate Debt Service, Maintenance Reserve Payments, Special Project Reserve Payments, and payments, if any, to the Charges Fund for such period or (ii) 1.20 times the Aggregate Debt Service for such period (excluding, for purposes of clause (ii) only, any payment due and payable by the Authority under a Qualified Swap upon an early termination thereof)."
