

<u>102-04-2020</u>

In a memorandum dated April 10, 2020, <u>Request for Authorization to Enter into a new</u> <u>Sponsorship Agreement with PNC Bank National Association and Live Nation Worldwide,</u> <u>Inc. for an additional five (5) years, plus one (1) renewal year to be exercised at the mutual</u> <u>agreement of the parties at an annual fee of \$1,316,236,</u> was approved.

The New Jersey Turnpike Authority (the "Authority") is currently a party to a Sponsorship Agreement with PNC Bank, National Association ("PNC") and Live Nation Worldwide, Inc. ("LiveNation"), which provides PNC with the naming rights to the Garden State Arts Center, along with certain other rights and privileges, for the annual fee of \$922,708 (the "Sponsorship Fee"). The Sponsorship Fee is shared equally with LiveNation under a separate Sharing Agreement. The parties have negotiated an increased Sponsorship Fee in the amount of \$1,316,236 for the next several years, subject to Board approval. PNC will also continue to provide the Garden State Arts Foundation, Inc., (the "Foundation") with a \$75,000 donation per year. Live Nation is the current operator of the PNC Bank Arts Center pursuant to and in accordance with the terms and conditions of a twenty-five (25) year lease agreement by and between the Authority and LiveNation.

The parties have proposed to amend and extend the Sponsorship Agreement for five (5) years until October 31, 2025, with an additional one (1) year renewal year, upon the following terms:

- PNC pays an additional Sponsorship Fee of \$1,316,236 per year;
- PNC shall pay \$75,000 Classical/Cultural Performances Contribution to the Foundation each year.
- Prior to the expiration of the current Sponsorship Agreement, PNC and the Authority shall commence a 180-day exclusivity period to negotiate a new Sponsorship Agreement, in accordance with the current renewal terms of the Sponsorship Agreement.

Accordingly, it is requested that the Board of Commissioners authorize the Executive Director to execute a Sponsorship Agreement with PNC and LiveNation, and a Sharing Agreement with LiveNation, pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization. ******

<u>103-04-2020</u>

In a memorandum dated April 22, 2020, <u>Authorization to Enter into Memorandum of</u> <u>Agreement with the State of New, Jersey, Department of Health ("DOH"), Budget</u> <u>Code: 444000-00-00-810, Amount: \$1,067,762.00 (over three (3) years)</u>, was approved.

The Authority has previously entered into agreements with DOH for the inspection, investigation and related health services for all retail food service facilities located on the New Jersey Turnpike and Garden State Parkway. These services are required by law, and the cost of these services is borne by the Authority. Additionally, the Authority will invoice HMS Host 65% and Sunoco 30%, respectively, of the costs of inspections, whereby the Authority will bear the remaining 5%. Furthermore, all remaining terms contained in the existing agreement shall be continued within the proposed agreement. The most recent agreement, approved by the Authority's Board of Commissioners in September 2017 under Agenda Item No. 236-09-2017, was effective from July 1, 2017 to June 30, 2020, at a cost to the Authority not to exceed \$1,024,745.00.

DOH has proposed a new three (3) year agreement that would be effective from July 1, 2020 to June 30, 2023, at a total cost to the Authority not to exceed \$1,067,762.00 over the threeyear period. The cost to the Authority represents less than a \$43,000 increase over the prior three-year agreement. The inspection services provided by DOH would include the facilities at nineteen (19) Service Areas and all concessions and the main and back stage kitchens at the PNC Bank Arts Center.

Accordingly, it is requested that the Board of Commissioners delegate to the Executive Director the authority to execute the Memorandum of Agreement with DOH pursuant to the terms outlined above. It is further recommended that the Commissioners authorize the Executive Director to execute any such other documents and take any such other actions as are deemed necessary to effectuate the intent of this authorization.

In a memorandum dated April 21, 2020, <u>Authorization to enter into an Amendment to</u> <u>the Amendment and Restated Lease Agreement with LiveNation Worldwide, Inc.</u> <u>("LiveNation") dated as of December 7, 2017 (the "Lease") to defer a rental payment from</u> <u>March 2020 to December 2020 and to increase the Authority's Minimum Percentage Rental</u>

In 2017, via Agenda item 2017-12-308, the New Jersey Turnpike Authority ("Authority") authorized the Executive Director to enter into an Amended and Restated Lease Agreement with LiveNation (the "Lease") to lease the Arts Center for twenty-five (25) years to 2042. The Lease provides that LiveNation be responsible to the Authority for annual fixed rental amounts, payable

Amount for 2020, was approved.

40% by March 30 of each year; 30% by June 30 of each year; and 30% by September 30 of each year (the "Minimum Fixed Rental Amounts"). Additionally, in the event that LiveNation's annual Gross Revenues exceed the Minimum Fixed Rental Amounts, LiveNation would be responsible to pay the Authority 10.5% of such Gross Revenues ("Minimum Percentage Rental Amount").

Due to temporary cash flow issues created by the Covid 19 pandemic, LiveNation has requested in writing that they defer their payment due March 2020, in the amount of \$1,176,203, to a later date, in exchange for increasing the Authority's Minimum Percentage Rent from 10.5% to 13.5% for 2020, capped at \$1,176,203. After negotiation, the parties agreed that the March 30, 2020 payment be deferred to December 31, 2020, with penalties for the payment waived. The parties also agreed that after 2020, the rental arrangement shall revert to the original financial terms for the Minimum Percentage Rental Amount as set forth in the Lease, all subject to Commissioner approval.

The proposed deferral of the Minimum Fixed Rental Amount due does not appear to negatively impact the Authority's income for 2020, as LiveNation will continue to be responsible for the same total annual Minimum Fixed Rental Amount. Further, this agreement will provide the Authority with the opportunity to increase its Minimum Percentage Rent for 2020 up to \$1,176,203. Accordingly, it is recommended that the Executive Director be authorized to execute an amendment to the Lease Agreement substantially as set forth above. It is further recommended that the Executive Director be authorized to take such further actions and execute such additional documents as are reasonably anticipated and consistent with the intent of the authorizations granted herein, including potential deferral requests for remaining 2020 payment obligations, provided that all 2020 rental amounts are fully paid by December 31, 2020.

In a document dated March 24, 2020, <u>Recommendation to Award Contract No.</u> <u>P200.252, Garden State Parkway, Midlantic Construction LLC, Shoulder Widening of the</u> <u>Garden State Parkway, Milepost 30 to 35, R-156622, Budget Code: 39200004, Amount:</u> <u>\$82,831,386.38, was approved.</u>

This contract involves widening of the northbound and southbound left and right shoulders of the Garden State Parkway to current standards from Milepost 30.0 to 35.0 in the Township of Egg Harbor and the City of Somers Point, Atlantic County. Additional work includes the reconstruction of eight bridges over local roadways, which will be widened to accommodate a future third lane, construction of stormwater management facilities, roadside improvements and utility relocations. The contract will also lengthen the acceleration and deceleration lanes at the Interchange 30 northbound entrance and southbound exit, and upgrade the existing roadway lighting at Interchange 30 to meet current standards. All work is expected to be completed by August 2023.

Six bid proposals were received on March 13, 2020 for the above publicly advertised contract, as shown on the attached bid summary sheet. The low bid proposal, in the amount of \$82,831,386.38, may be compared to the Engineer's Estimate in the amount of \$84,522,901.35. The low bidder, Midlantic Construction LLC has performed work for the Authority and is considered competent to complete this contract.

It is, therefore, recommended that Contract No. P200.252 be awarded to the low bidder, Midlantic Construction LLC of Barnegat, New Jersey in the amount of \$82,831,386.38. This award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. Bids for this work were procured, and the authorization being sought is to award this contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).

The General Consultant, HNTB Corporation, concurs with this recommendation.

In a document dated April 6, 2020, <u>Recommendation to Award Contract No. T200.497</u>, <u>New Jersey Turnpike, Crisdel Group, Inc., Interchange 14, Concrete Roadway Repairs and</u> <u>resurfacing R-156057, Budget Code: 080C00036, Funding Allocation: \$ 3,000,000.00 FY</u> <u>2020, \$ 6,785,000.00 FY 2021, Amount: \$ 9,785,000.00</u>, was approved.

This contract involves localized full-depth repairs to existing reinforced concrete pavement, including resurfacing with warm mix asphalt surface course pavement and other

incidental improvements on roadways and ramps under the jurisdiction of the New Jersey Turnpike Authority outside of Interchange 14 in the City of Newark, Essex County. All work is expected to be completed by November 2021.

Three bid proposals were received on April 1, 2020 for the above publicly advertised contract, as shown on the attached bid summary sheet. The low bid proposal in the amount of \$9,785,000.00 may be compared to the second low bidder in the amount of \$9,992,517.00. The bids were lower than the Engineer's Estimate in the amount of \$11,610,795.00 likely due to Crisdel's proximity to the jobsite, as well as a continued downward trend in the cost of the price of asphalt and fuel allowing them to more aggressively bid the asphalt pavement items of work. The low bidder, Crisdel Group, Inc. has performed work for the Authority and is considered competent to complete this contract.

It is, therefore, recommended that Contract No. T200.497 be awarded to the low bidder, Crisdel Group, Inc. of South Plainfield, New Jersey in the amount of \$9,785,000.00 allocated as follows: \$3,000,000.00 for FY 2020 and \$6,785,000.00 for FY 2021. This award is contingent upon the Treasurer of the State of New Jersey completing the review of all documents submitted by the selected awardee, pursuant to Public Law 2005, Chapter 51 (formerly Executive Order 134) and Executive Order 117 (Corzine 2008), and having no objection to same. Bids for this work were procured, and the authorization being sought is to award this contract to the lowest responsible bidder, in accordance with N.J.S.A. 27:23-6.1, N.J.A.C. 19:9-2.2, and Executive Order No. 37 (Corzine 2006).
