## **NOTICE OF PUBLIC HEARING FOR A TOLL ADJUSTMENT AND ESTABLISHMENT OF A NEW TOLL**

**PLEASE TAKE NOTICE** that, in accordance with N.J.S.A. 27:23-5.10 and -5.11, the New Jersey Turnpike Authority (the "Authority") will conduct public hearings relative to a proposed adjustment to existing tolls and establishment of a new toll on the following days and times, at the following locations:

Representatives of the Authority will be available at each hearing to discuss the proposed capital plan and associated funding requirements and to receive oral and written testimony from members of the public relative to the proposal. The public record will remain open until Friday, March 27, 2020 for receipt of written comments. Written comments should be directed, via U.S. Mail, hand delivery or courier, to the attention of the Executive Director, New Jersey Turnpike Authority, 1 Turnpike Plaza, P. O. Box 5042, Woodbridge, New Jersey 07095 or via E-Mail to [njtapubliccomments@njta.com](mailto:njtapubliccomments@njta.com). Written comments received after March 27, 2020 will not be considered.

The proposal under consideration by the Authority is:

1. Proposed Actions on the New Jersey Turnpike (the "Turnpike")

To adopt capital design and construction projects as shown on Exhibit A, attached, and to adjust the calendar year 2020 toll schedule such that an average trip for a passenger vehicle would increase by no more than \$1.25.

2. Proposed Actions on the Garden State Parkway (the "Parkway")

To adopt capital design and construction projects as shown on Exhibit B, attached, and to adjust the calendar year 2020 toll schedule such that an average trip for a passenger vehicle would increase by no more than 30 cents.

3. In the case of both the Turnpike and the Parkway:

- A. Pro rata increases, similar to the proposal for passenger vehicles on the Turnpike and Parkway, will be applied to other classes of vehicles.
- B. Existing bus discounts will be rescinded and a new uniform discount of 40% will be applicable to all buses.
- C. Beginning in calendar year 2022, tolls are proposed to be indexed at an amount to be determined, but in no case more than three per cent (3%) annually.

4. A toll will be established at the new Interchange 19W on the western spur of the Turnpike in accordance with the attached Exhibit C.
