NOTICE IS HEREBY GIVEN that the New Jersey Turnpike Authority (the "Authority") will hold a Virtual Public Hearing in compliance with Executive Order 172 (Kean 1987) for the purpose of taking public comments on the proposed project, which includes intersection, roadway and lighting improvements in the vicinity of the Garden State Parkway PNC Bank Arts Center (the "Project") located in the Township of Holmdel, Monmouth County.

The Project is intended to improve the operation of the East-West PNC Service Road through a reconfiguration that will improve safety by providing conventional right-hand-side drive operation. Additionally, the intersections with the Garden State Parkway northbound and southbound exit ramps with the East-West PNC Service Road will be improved. The project will also include lane control system improvements, roadway and parking lot lighting improvements, pedestrian ADA and access improvements, stormwater management, resurfacing, signing, striping, and other ancillary work.

In keeping with the emergency orders issued by Governor Murphy as a result of COVID-19, the hearing will be held virtually on February 17, 2021 at 6:00 p.m. The virtual hearing will be held via WebEx and will provide for public access via the web or telephonically.
