Responses to Inquiries:

1. Please clarify if the Exceptions Form in Section III, B. on page 14 of the attached RFB is to be completed with the bid response. What is the purpose of the Exception Form?

RESPONSE: If bidder is proposing equivalent items for consideration by the Authority.

2. Please confirm that as a services provider, a surety bond needs to be provided with the RFP response.

RESPONSE: Per Section I, B.5 (a), page 3, Bid Bond, Letter of Surety or a Cashier's Check for 10% of the amount Bid is not required.

3. Please confirm the projected volume for the contract, so that if a bid bond is needed the 10% can be determined.


RESPONSE: See response to question 2.

4. Can line items be added to the price sheet around the litigation fees?

RESPONSE: No, Per Section II, C.2 on page 5, Bidders must quote only one price per line item. If a Bidder quotes multiple prices per line item, the Bid may be rejected.
