REQUEST FOR BIDS RM-169218 ARMORED CAR SERVICES

Below are the New Jersey Turnpike Authority's responses to inquiries received with respect to the above-referenced Request for Bid ("RFB").

Responses to Inquiries:

1. Can we please request a 2 week extension on top of the original bid as there is a lot of documents to sift through and we want to be competitive on the bid to make sure we can give you competitive pricing.

RESPONSE: The Authority cannot extend due date. RFBs are due May 10, 2023 by 11:00 am.

- 2. Can we have a zip code table for every location or if not then a map so we can figure out which branch would handle what.
 - a. A zip code is preferrable

RESPONSE: See attached.

3. I saw you use PNC as your bank. Would this be the financial institution for all locations?

RESPONSE: The Armored Car provider is not required to go to the financial institution. The Armored Car provider is required to pick up and drop off cash deposits collector money bags and deliver them to the money counting facility which will be located in Brooklyn, New York. The Armored Car provider is also required to drop off imprest fund deliveries as well as fulfill and deliver imprest fund orders.

4. Is 7 days a week service a deal breaker? Brinks only operates 5-6 days a week depending on the proximity and the 7th day is not ideal.

RESPONSE: It is vital to the operations of the Tolls and Finance departments that 7 day a week pickup/drop off service be provided to all Turnpike Interchanges and GSP Barriers as stated in this RFB "Shall be performed Monday through Sunday". This would be a deal breaker.

5. Are the time frames form 7am-2pm or 9am-2pm firm? Or is there any room for error?

RESPONSE: The time frames from 7am-2pm or 9am-2pm as stated in the RFB are preferred but can be flexible.

6. What are the cash volumes you are looking to have deposited on a daily basis?

RESPONSE: We are not looking to have revenue deposited on a daily base. The cash volumes for pickup/drop off on a daily base for Turnpike ("TPK") and Garden State Parkway ("GSP") revenue are as follows:

TPK-\$260,000.00 approximate total GSP-\$120,000.00 approximate total
