- 2. Section II; E., Line 2, Column D on the Bid Quotation Sheet remove D001.

Failure to acknowledge receipt of Addendum may be considered as grounds for rejection of bid by the Authority, however, in the discretion of the Authority, submission of the signed bid may be treated as acknowledgement of receipt of this Addendum.

Below are the New Jersey Turnpike Authority's responses to inquiries received with respect to the above-referenced Request for Bid ("RFB").

## **Responses to Inquiries:**

1. Line 1 on quotation sheet is described under Column D as Flammable Liquid, Toxic, NOS, UN1203, II, D001, D018. Would you please clarify what makes the liquid toxic?

ANSWER: A major focus of our remediation projects pertain to benzene contamination. For situations where the benzene is 0.5 mg/L or higher, it would be classified as toxic. If it does not meet that level, it would be labeled as only D001.

2. Line 2 on quotation sheet is described under Column D as Non-Flammable Liquid, Toxic, NOS, UN1203, II, D001, D018. D001 is associated with flammable materials. Gasoline (UN1203) is described as toxic. Is this correct? Gasoline is typically classified as a Class 9 material. Would you please clarify what makes the liquid toxic?

ANSWER: D001 was included as mistake and needs to be removed. This line item will apply to general non-flammable mixtures as well as mixtures with a benzene 0.5 mg/L or higher (toxic).

3. Line 3 on quotation sheet is described under Column D as Flammable Liquid, Toxic, NOS, UN1203, II, D001, D018. Would you please clarify what makes the liquid toxic?

ANSWER: Refer to answer # 1.
