## **SECTION I**

#### A. <u>INTRODUCTION</u>

The New Jersey Turnpike Authority (the "Authority") was created by an act of the New Jersey Legislature in 1948, known as the New Jersey Turnpike Authority Act (as amended and supplemented, "Act"). The Act authorizes the Authority to construct, maintain, repair, and operate the New Jersey Turnpike, to collect tolls, and to issue Turnpike Revenue Bonds or Notes, subject to the approval of the Governor, payable from tolls and other revenues of the Authority. On May 27, 2003, the Act was amended to empower the Turnpike to assume all powers, rights, obligations and duties of the New Jersey Highway Authority (the "Highway Authority"), which owned and operated the Garden State Parkway and PNC Bank Arts Center. On July 9, 2003, the Authority assumed all powers, rights, obligations and duties of the Highway Authority. The Authority currently operates both the Garden State Parkway ("GSP") and the New Jersey Turnpike ("Turnpike") (both roads are collectively referred to herein as the ("Roadways").

The Authority is governed by an eight-member Board of Commissioners ("Board"). The Governor of New Jersey appoints each of its members and has the statutory authority to overturn an action of the Board by vetoing any Board action within 10 days of receiving the minutes of the meeting. The Board authorizes awards of all public contracts over \$100,000, except in cases where it has delegated authority to the Executive Director.

This bid solicitation is being conducted pursuant to the Authority's enabling statute as found in *N.J.S.A.* 27:23-6.1 and Executive Order number 37 (Corzine 2006) and the regulations and policies of the Authority with regard to public bid procurement.

#### B. BIDDER GUIDELINES/CHECKLIST

## **SECTION II**

# A. INTENTION

- 1. **Sealed Bids** (<u>Paper Submission Only</u>) for <u>RM-187706</u> must be received at the New Jersey Turnpike Authority Administrative Offices, 1 Turnpike Plaza, Woodbridge, New Jersey 07095-5042 by the due date and time stated on the cover of this "RFB".
- 2. Bidders mailing Bids should allow for their normal mail delivery time to ensure timely receipt of the Public Bids. Please be advised that using an overnight/next-day delivery service does not guarantee overnight/next-day deliveries to our location. The Authority will not be responsible for any Bid not being received by the required date and time.
- 3. It is the intention of the Authority to issue a Purchase Order/ "NOA" for the supply of treated and untreated rock salt in accordance with the enclosed Material and Salt Specifications ("Specifications") and Contract. The supply of granular sodium chloride (Rock Salt) is to be treated with liquid magnesium chloride and organic based performance enhancer (OBPE) (collectively "Treated Rock Salt") and delivered to locations listed in this RFB. The pick-up of material is optional and included in the bid sheets but will not factor in the Basis of Award.
- 4. Items purchased under this contract will be delivered as directed by the Authority.
- 5. The term of the contract shall be for "one year with the option to extend for two additional one-year terms at the Authority's discretion and the vendor's concurrence".

# B. BID SHEET INSTRUCTIONS

- 1. Bidders must follow all instructions in this RFB and in the Instructions to Bidders issued by the Authority, and any other documents issued by the Authority in connection with this RFB (collectively, "Bid Documents").
- 2. Bidders must examine the bid documents carefully before bidding and must ask the Director of Procurement and Materials Management Department ('PMM") in writing for any interpretation or correction of any apparent ambiguity, inconsistency or apparent error therein. If necessary, an interpretation or correction to the specifications in the form of an addendum shall be issued at least three (3) days prior to the bid opening by the Director of PMM to Bidders who have obtained the Bid Documents in accordance with *N.J.A.C.* 19:9-2.2(a)(3). **Requests for interpretation or correction shall be considered only if received at least 5 business days prior to the Bid opening date**. - 3. The submission of the Bid is conclusive evidence that the Bidder is fully aware of the conditions, requirements, and details as stated in the Bid Documents. If the Bidder, prior to submitting its Bid, fails to notify the Director of PMM of the existence of an ambiguity or inconsistency in the Bid Documents, a Bid will conclusively be presumed to have been based upon the Authority's interpretation of such ambiguity or inconsistency.

- 4 All erasures, interpolations or other physical changes on the Bid form shall be signed or initialed by the Bidder. Bids containing any conditions, omissions, erasure's, alterations, or items not called for in this "RFB" or irregularities of any kind, may be rejected by the Authority, in its sole discretion.
- 5 The Bidder shall not attach conditions, limitations or provisos to its Bid.
- 6 The Authority will accept Approved Equivalent items on this Bid. If a Bidder is basing the RFB on items other than what is specified, and wishes the items proposed to be considered as an "Approved Equivalent", the Bidder shall enter a price on the Bid sheet then submit on the Exception Form in the exact format of the line item on the RFB contained herein, the item number, an item description including manufacturers name, model number, informational brochure(s), and packaging quantities of those items that the Bidder proposes to substitute.

## C. BASIS OF AWARD

- 1. Bidders are required to submit unit prices for delivery of Treated Rock Salt to designated locations. See the definition of delivery ("Delivery") in Section III.C (p. 17) of the Specifications. In addition, details of the mile markers and exact locations can be found in Appendix A.
- 2. All quantities of Treated Rock Salt listed in the bid sheets are <u>annual estimated requirements</u> (tonnage). In order to ensure adequate supply of Treated Rock Salt, the listed requirements per location are allocated on a 50/30/20% split between primary, secondary and tertiary vendors. 50% of a location's requirement will be awarded to a primary vendor; 30% will be awarded to a secondary vendor and; 20% will be awarded to the tertiary vendor as outlined in the bid sheets. <u>Bidders may bid on one or multiple locations as a primary vendor, secondary vendor and a tertiary vendor. However, Contracts shall only be awarded to the lowest bidder in each category. No vendor may be awarded the same location in more than one category.</u>
- 3. Bidders must quote only one price per line item. <u>If a Bidder quotes multiple prices per line item, the Bid may be rejected</u>.
- 4. Note, that the quantities listed for each location in Section III.C.7 of this RFB are the Authority's annual estimated requirement for that location. In the resulting Agreement(s), the Authority is obligated to guarantee 40% of the annual estimated requirement (tonnage) listed for each location during the contract period as a minimum guarantee.
- 5. All items are to be Bid FOB Destination. All shipping, handling, and other costs should be considered in the Bid price(s).
- 6. The Authority is tax exempt from New Jersey Sales and Excise Tax.
- 7. Award will be made to the lowest responsible and responsive bidder with the lowest total extended amount for each individual location.

## **D. MISCELLANEOUS**

1. ## **SECTION III**

# A. SPECIFICATIONS – TREATED ROCK SALT

#### A. Intention

It is the intention of the New Jersey Turnpike Authority ("Authority") to procure approximately 121,000 tons of Treated Rock Salt per specifications for the New Jersey Turnpike ("Turnpike") and the Garden State Parkway ("Parkway"). This quantity is the annual estimated tonnage for one (1) year. The intended use of this product is to treat roadways for snow and ice control. It is also the intention of the Authority to secure pricing for approximately up to 20,000 tons of Untreated Rock Salt. (See Section IV, pg. 24 for Specifications.)

The intent of the Authority is to award a contract(s) to the lowest responsible bidder(s) whose bid, conforming to this RFB, is most advantageous to the Authority. The intent is to select Vendor(s) to deliver Treated Rock Salt per the specifications to specific Maintenance Locations listed within. These locations are represented in the pricing description bid sheets in the Request for Bid document.

Any product the Vendor will supply the Authority must meet current OSHA standards.

## EVAPORATED, SOLAR, OR OTHER SALT SHALL NOT BE FURNISHED IN LIEU OF ROCK SALT.

#### B. Award

The Authority will award Contract(s) based on the lowest responsible bid price submitted within each location. Bidders are encouraged to bid each and every location either as Primary, or Secondary, or Tertiary Vendors. The Authority reserves the right to select different Vendors for each delivery location. Contracts shall be awarded to the lowest responsible bidder in each category however, no vendor may be awarded the same location in more than one Vendor category. The delivery locations are shown in Appendix A.

#### C. <u>Delivery Description and Requirements</u>

## 1. Delivery Locations

The Authority has twenty-nine (29) delivery locations on both Roadways. Each of these locations has a salt storage facility located on the premises for use in snow/ice removal. The delivery locations and mile marker locations are detailed in Appendix A. (p.31)

#### 2. Minimum Order

There is a minimum order of 25 tons per individual location.

#### 3. Order Placement

All orders will be placed by e-mail or phone call. The official order date shall be the date of the e-mail or phone call if received by the Vendor before 2:00 p.m. (all order times reflect Vendors' time) and the next day if received by the Vendor after 2:00 p.m. The Vendor must confirm by phone or e-mail (to the Maintenance Department employee who placed the order) receipt of the order and an estimate of the shipment date within 2 business hours. Business hours will be defined as Monday through Friday, 8:00 AM to 4:00 PM. The Vendor will also need to provide 24-hour access to a contact person(s) of the Vendor, either via cell phone or another method approved by the Authority. This person(s) will assist in order processing, product production and logistical scheduling and

delivery coordination. This contact line must be available during after business hours, weekends, and holidays, from October 15 through April 15 of the contract term.

#### 4. Deliveries

Delivery shall be made in accordance with instructions on e-mailed or telephone orders from the Authority designated representative. If there is a discrepancy between the order and what is listed on the contract, it is the **Vendor's obligation** to seek clarification from the Maintenance Department's representative and, if applicable, from the Authority's Procurement and Materials Management Department.

The Authority desires to maintain at each storage facility no less than a 50% minimum quantity on-hand. Therefore, due to some locations having limited storage capacity, these locations must be replenished on a priority basis as directed by the Maintenance Department's representative.

Completed delivery will be required at the latest according to the following schedule:

Vendor will be required to deliver a minimum of 200 tons per day after the initial 600-ton delivery. In the event there are multiple orders placed for the same delivery location, they will be viewed as a single order and will be subject to a 200 ton per day minimum delivery.

For example, an order of 1,400 tons placed on Monday will be delivered as follows (or sooner):

If a scheduled delivery occurs on a holiday, the next weekday will be the delivery date.

For any location having a minimum on-hand quantity of less than 50% of their capacity, completed delivery, at the latest, is required within five (5) calendar days after receipt of order.

The guaranteed delivery in number of calendar day(s) required to make delivery after receipt of a written or verbal order shall be applicable and the Vendor is obligated to honor same through April 15th of each year. However, from April 16<sup>th</sup> to September 30<sup>th</sup> of each year, delivery shall be at the option and discretion of the Vendor.

Although Vendors are expected to make every effort to meet the delivery dates, some allowances may be made for extreme road and/or weather conditions (i.e., road closures which severely restrict truck traffic). <u>Allowances must be approved by the Authority</u>.

Product shall be shipped in bulk delivery. All shipments of product shall be totally covered with a waterproof tarpaulin or similar sheeting material. Torn or ripped coverings may be cause for rejection of shipment. Also, evidence of free-flowing water/brine in particular shipments may be cause for rejection. Product shall be received in a free-flowing and usable condition.

All shipments of salt shall be accompanied by a weight ticket of a licensed weigh master indicating the producer, net weight of the delivery, and in the case of bulk delivery, the stockpile source. The certification must bear the weigh master's signature; weights shall be recorded from a scale equipped with a weight printing device. Handwritten weights are not acceptable.

#### 5. Delivery Time Requirements

Scheduled deliveries shall be made during normal working hours (Monday through Friday between the hours of 8:00 A.M. and 3:00 P.M. for Turnpike locations and Monday through Friday between the hours of 7:00 A.M. and 2:00 P.M. for Parkway locations.), unless otherwise requested or agreed to by the Authority employee who requested the material.

The <u>Vendor's trucks shall be responsible for all tolls incurred during the delivery of product</u>. Any entrance and exit from the same interchange will constitute and illegal U-turn and will result in the highest possible tariff being charged.

#### a) Scheduled Delivery:

Delivery shall be made no later than (5) five calendar days or less from the order date. Delivery will be allowed during the weekend and holidays only if the ordering agency deems it necessary. No additional remuneration will be made for a Saturday, Sunday, or Holiday delivery.

#### b) Pick-up Pricing:

Bidders are requested to bid a price for the Authority or an authorized agent to pick-up materials at the Vendor's distribution facility(s). It is the desire of the Authority to maintain on hand quantities not less than 50% of capacity at each of its locations. In the event on hand quantities are less than 50% of capacity at a location(s), the Authority may invoke the option to pick up material. The Vendor shall make accommodations that will enable the Authority or its authorized agent to pick up material.

#### 6. Price Escalation Based on Exceeding -150 % of Authority Requirement(s):

A price escalation will be permitted when delivery exceeds 150% of listed requirements per delivery location. The price increase will be based upon the CPI Index for the preceding year, however the maximum increase permitted shall be five percent (5%).

#### 7. Minimum/Maximum Obligations:

The Authority is obligated to take a 40% minimum of their listed annual requirements during the contract period and Vendors are obligated to deliver up to 150% of the requirement for Treated Rock Salt. The minimum/maximum delivery quantities will be based on each delivery location. The requirements are listed below by location.

#### 8. On Ground/Delivered Inventory:

The Vendor shall have the following on-ground/delivered inventory reserved for the Authority as follows:

October 1, 2024 - 50% of listed requirement for awarded locations

November 1, 2024 - 70% of listed requirement for awarded locations

December 1, 2024 - 80% of listed requirement for awarded locations

January 1, 2025 - 100% of listed requirement for awarded locations

After January 1, 2025, the Vendor is obligated to maintain inventories adequate to provide deliveries as requested in the time frames and quantities requested.

If, at any time during the contract period, it is determined by the Authority that the Vendor does not have adequate inventory, the Authority reserves the right to purchase the product from another Vendor.

#### 9. Material Suitability and Liability:

Any loads found to be contaminated may be subject to rejection with all related cleanup and/or replacement costs to be borne by the Vendor.

Deviation from specifications may result in rejection of any delivery. All costs associated with rejected deliveries shall be the responsibility of the Vendor. Should a product be found to be contaminated (after application), with non-specified elements, and become cause for environmental concerns, that necessitate clean-up of yards, storage facilities, or roadsides, etc., the Vendor shall be responsible for any, and all expenses incurred.

#### 10. Delivery and Documentation:

Each bid shall be accompanied by a current MSDS sheet. This stipulation is extremely important, and <u>MSDS</u> sheets for all products offered in the bidding process must be attached to the bid.

#### 11. Bill of Lading

The bill of lading for each shipment must contain the following information.

- 1. Name of product.
- 2. Vendor and manufacturer of product.
- 3. Customer must be listed as New Jersey Turnpike Authority.
- 4.. Delivery Destination and Authority Division (Turnpike or Parkway).
- 5.. Total number of tons being delivered.
- 6. Total weight of delivery using a certified scale ticket. The Authority may at any time choose to spot check a delivery of product by having the load weighed on certified scales before and after delivery to ensure the accuracy of the flow meter. No additional cost will be charged to the Authority for spotchecking deliveries of products.

#### 12. Invoice Processing:

Payments will not be processed by the Authority until the contract products have been delivered in satisfactory condition or services have been satisfactorily performed. Invoices must contain sufficient data including but not

limited to contract number, description of product or service, order number, delivery location, quantity, unit and price per unit as well as federal identification number.

No single invoice containing deliveries for both the Parkway and Turnpike divisions will be paid, as the Roadways must be billed separately. Invoices must be sent directly to the Authority's Accounts Payable Section:

The Authority will not process invoices for payment until the Vendor has met all requirements under this section. All invoices shall include the following:

- 6. Unit of Measure
- 7. Delivery Location

Upon Request, the Vendor must provide the Authority with a copy of a delivery ticket and/or bill of lading signed by an Authority Representative prior to payment being made.

#### 13. Reports of Contract Purchases and Open Balances:

The Vendor(s) shall furnish reports of purchases made from the contract every month during the contract period. The critical reporting time period is October to April.

The reports shall be in the following format:

The reports are to be submitted to the Authority's Maintenance Department. The open balance reports shall reference the location, the order number, tons ordered, tons delivered and any open balance. These reports should be e-mailed to the Maintenance Department at end of every week and are to be sent before the start of a new week. This report will assist the Authority's Maintenance Department in assuring the Vendor is meeting required delivery rates. The Reports also assists in the prioritizing deliveries and schedules. Failure to submit the required report may be cause for delays in paying invoices.

#### D. Other Contract Conditions/CPI

#### 1. Contract Period and Renewals

The contract prices shall remain firm for **one** (1) **year**. Should the Authority exercise its option to extend the contract for additional year(s), the rate may be adjusted yearly based on the Consumer Price Index (CPI) as designated in the average CPI for the combined New York City/Northern New Jersey and Philadelphia/Southern New Jersey areas between April 2024 and April 2025, however, the maximum increase permitted for any year of the contract shall be five percent (5%).

The benchmark for calculation purposes shall be the difference in the CPI from the previous base year and calculated yearly for each contract thereafter with the year ending in April. The bidder's prices shall remain firm for **one** (1) year. Should the average CPI decrease between the completed contract year and the next year of the contract, the Contractor's rate shall remain the same for the up-coming option year(s) of the contract as the most recently completed contract year, i.e., there will be no decrease.

## **B. SPECIFICATIONS – SALT**

GRANULAR SODIUM CHLORIDE TREATED WITH LIQUID MAGNESIUM CHLORIDE AND ORGANIC BASED PERFORMANCE ENHANCER (OBPE)

#### A. Intention

It is the intent of this specification to describe a mixture of Sodium Chloride Type "A" crushed rock salt treated with Liquid Magnesium Chloride and OBPE or an approved equivalent. The liquid treatment is intended to enhance the performance of the regular rock salt over untreated salt by reducing corrosiveness, improving low temperature performance, reducing bounce and scatter, preventing clumping, salt pile freezing and enhancing flow ability. The treated salt is handled, spread and stored by using the same equipment that is used for untreated salt. The intended use of the treated salt is to facilitate snow and ice prevention and removal on the Turnpike and Parkway roadways, bridges, parking lots and sidewalks.

#### **B.** Description

The finished product shall be composed of two primary components:

- 1. Crushed rock salt as described and specified in Section IV.C.
- 2. Liquid magnesium chloride and liquid organic based performance enhancer (OBPE) as described in Section IV.D.

The two components shall be mixed to produce a finished product as described in Section IV.E. The final product shall meet all the requirements described in Sections IV.F and G.

#### C. Sodium Chloride Type "A" Crushed Rock Salt Specifications

The crushed rock salt used in the preparation of the final product shall meet the following requirements.

- 1. Contamination
  - Upon inspection, the material shall be uniform in appearance, free flowing and free from visual evidence of foreign matter including but not limited to dirt, stone, chips, trash or any other material that could reasonably be expected to interfere with the use, handling or storage of the salt.
- 2. Chemical Composition
  - The rock salt shall be not less than 95% Sodium Chloride. Percent of Sodium Chloride shall be determined in accordance with current ASTM-D-632.
- 3. Size Grading
  - The rock salt, when tested using sieves as described in ASTM-C-136 (\*) shall conform to the following requirements for particle size distribution:

95 - 100
20 - 90
10 - 60
0 - 15

- \* A drying temperature of  $110^{\circ}\text{C} \pm 5^{\circ}\text{C}$  should be used.
- Tolerance of 5 percentage points on the maximum value of the range for each sieve except 1/2" (12.5 mm) and 3/8" (9.5 mm) sizes, on which no tolerance will be allowed.

#### 4. **Moisture Content**

Moisture content of the rock salt shall not exceed 1-1/2%\* when determined as follows:

% Moisture =  $(W_1 - W_2) / (W_1) \times 100$ 

where:  $W_1$  = Initial weight of sample

 $W_2$  = Weight of sample after drying to a constant weight at  $110^{\circ}$ C  $\pm$   $5^{\circ}$ C.

\* Procedure shall be in accordance with American Water Works Association B200-88, Section 4.3. A tolerance of 0.5% will be allowed before a non-complying product -moisture - price deduction is assessed.

#### 5. Sampling

Sampling shall be done in accordance with current ASTM-D632. The New Jersey Turnpike Authority, or any of its authorized representatives, reserves the right to take samples from the Vendor's stockpile or transfer point. The Authority retains the right to waive the on-site inspection for incumbent vendors with existing treated salt contracts.

#### 6. Acceptance

The rock salt may be rejected if it fails to conform to any of the requirements of this specification.

#### 7. Non-Complying Product- Price Deductions

Non-Complying Product - Price Deduction - Moisture

If the moisture content of the rock salt is found to be above 2.0 %, a deduction for moisture content will be made from the delivered bid price based on the following formula:

Reduced Price/Ton = Delivered Contract Price/Ton x (1.02 - 2X)

Where: X = Moisture content of the sample (expressed as the decimal equivalent of the percentage of the moisture content to the nearest 1%)

Non-Complying Product - Price Deduction - Gradation (Particule Size Distribution) b.

If, after delivery, the gradation of the rock salt is found to be out of tolerance, a deduction from the price shall be made based on the following formula:

Reduced Price/Ton = Delivered Contract Price x (1.00 - Y)

where: Y = the decimal equivalent of the total percentage of the sample out of gradation. The percentage out of tolerance, for the sample, for each sieve shall be to the nearest 1%.

Page 25 RM-187706

The sum, as described in section A.3, of the individual sieve tolerance deviations shall be used as Y.

#### c. General

A non-complying product - price deduction is not to be assessed unless the proper analysis and test procedures are followed. If the Vendor consistently delivers salt found to be above 2% moisture content or consistently not conforming to the gradation requirements, the contract shall be subject to cancellation either in whole or in parts.

#### d. Calculations

Calculations performed relative to this specification shall be made using the rounding off method of "ASTM Recommended Practice E-29 for Designating Significant Places in Specified Limiting Values".

#### D. Liquid Magnesium Chloride and OBPE

Material used for this component of the finished product shall be a 1 to 1 blend (1:1) of liquid magnesium chloride and liquid OBPE sufficient to allow the finished material to meet the specific requirements and performance criteria listed below.

Note: Sections B1 and B2 apply only to products offered that <u>do not</u> have a Beneficial Use Determination (BUD) from New Jersey Department of Environmental Protection. HOWEVER, ALL PRODUCTS MUST CONTAIN 250 PPM OR LESS PHOSPHORUS WITH OR WITHOUT BENEFICIAL USE DETERMINATION, NO DILUTIONS ALLOWED PRIOR TO PHOSPHORUS TESTING.

1. Bids shall not be accepted on any product that contains constituents in excess of the following established total concentration limits. Results are stated as Parts Per Million (ppm). If product exceeds any of the following constituents, then the bidder shall identify the exception(s) and explain any mitigating circumstances. The New Jersey Turnpike Authority reserves the right to evaluate these exceptions and make a determination of product eligibility based on the best interests of the Authority.

- 2. pH The pH of submitted liquid chemical product shall be 6-8. The pH limit of liquid chemical product may be waived by the New Jersey Turnpike Authority. The right to waive the pH will be at the discretion of the New Jersey Turnpike Authority. The New Jersey Turnpike Authority's decision to waive the pH requirement shall be in the best interest of the Authority and shall be final.
- 3. Material shall contain 15% MgCl<sub>2</sub> by weight plus or minus 2%.
- 4. Material shall contain 21% plus or minus 2% OBPE or approved equivalent to produce a final material having a eutectic (freezing) point of -20°F or lower.

- 5. A table showing Freezing Point-Specific Gravity for various percentage dilutions of product in water shall be provided. Table shall include data starting from at least 5% product in water and continue to include the percentage product in water to produce the eutectic (lowest freezing point) composition.
- 6. A 3% solution of the corrosion inhibited chemical product shall have a corrosion value of at least 70% less than that of a 3% solution of Sodium Chloride. (Determined by NACE (National Association of Corrosion Engineers) Standard TM-01-69 as modified by PNS (Pacific Northwest Snowfighters).
- 7. This chemical product shall not contain greater than 4.0% Total Settleable Solids and shall have ninety nine percent (99.0%) of the Solids Passing through a Number 10 sieve after being stored at -17.8°C +/-  $1^{\circ}$ C ( $0^{\circ}$ F +/-  $2^{\circ}$ F) for 168 hours.
- 8. An independent certified analysis showing compliance with all the above requirements must be submitted with the bid along with an intended use statement for the product. Exceptions to the requirements **must** be stated with the bid submitted and the Authority reserves the right to reject the product if not approved as an approved equivalent.
- 9. The bidder must submit a material safety data sheet (MSDS) for the product.

#### E. Mixing the Sodium Chloride and Magnesium Chloride/OBPE

The materials described in Section C and Section D shall be mixed as described in this section to produce the finished product. Mixing procedures shall comply with all requirements described in this section.

- 1. The Authority, or any of its authorized representatives, reserves the right to take samples from the Vendor's stockpile or transfer point before the salt is mixed with the Liquid Magnesium Chloride and OBPE. Both salt and liquid samples may be taken. The Authority retains the right to waive the on-site inspection for incumbent vendors with existing treated salt contracts.
- 2. The Vendor will thoroughly mix a minimum of 8 gallons of Liquid Magnesium Chloride and OBPE per ton of salt.
- 3. The Vendor will ensure a consistent thorough mix (e.g. spray system, **pug mill**, conveyor) so that there is maximum coverage of the liquid on the salt crystals. Loader mixing and stockpile injection methods are not acceptable. The Vendor must specify the mix method in the submitted bid.
- 4. Trucks hauling the product must be weighed on certified scale with printout after loading the final product (salt and liquid mixture) and prior to arriving at the delivery destination. The weight ticket shall include the net weight of the final product and the stockpile source. The certification must bear the weighmaster's signature. Handwritten weights shall not be acceptable.
- 5. All shipments of finished product shall be accompanied by a ticket indicating the amount of Liquid Magnesium Chloride and OBPE mixed in the finished product. This amount will be indicated on the ticket by gallons.
- 6. The finished product shall be shipped via bulk delivery. Trucks delivering the product shall have the entire cargo area completely covered by a waterproof tarpaulin or similar sheeting material. Torn or ripped covers may be cause for rejection of the shipment.

7. The Authority reserves the right to, at any time, inspect the operation to take salt and liquid product samples, to ensure that the proper amount of liquid product is being applied and that the mix method is appropriate.

## F. Final Product: Rock Salt treated with Liquid Magnesium Chloride and OBPE

The Treated Salt shall meet the following requirements:

#### 1. Contamination

Upon inspection of delivered salt, the material shall be uniform in appearance, free flowing and free from visual evidence of foreign matter including but not limited to dirt, stone, chips, trash or any other material that could reasonably be expected to interfere with the use, handling or storage of the salt.

#### 2. Flowability

Properly stored product (covered or inside storage) shall be uniform and free flowing in a manner consistent with its intended use and shall show no objectionable clumping or caking.

#### 3. Leaching

Properly stored product (covered or inside storage) shall show no indication of objectionable leaching or separation of components to the extent that such condition produces adverse effects in the handling or usage of the product or routine maintenance of the storage facility.

#### 4. Chemical Composition

Shall be not less than 91.2% Sodium Chloride. Percent of Sodium Chloride shall be determined as follows: Apparent total percent Sodium Chloride content shall be determined in accordance with current ASTM-D-632. Magnesium and Calcium content shall be determined in accordance with ASTM E-534 and computed as percent Magnesium Chloride and percent Calcium Chloride respectively. Percent Sodium Chloride shall then be computed as follows:

% Sodium Chloride = % Apparent Sodium Chloride - (% Magnesium Chloride + % Calcium Chloride)

## 5. Size Grading

The salt, when tested using sieves as described in ASTM-C-136 (\*) shall conform to the following requirements for particle size distribution:

Sieve Size	Percent Passing (**)
1/2" - (12.5 MM)	100
3/8" - (9.5 MM)	95 - 100
No. 4 - (4.75 MM)	20 - 90
No. 8 - (2.36 MM)	10 - 60
No. 30 - (600 Microns)	0 - 15

- \* A drying temperature of  $110^{\circ}\text{C} \pm 5^{\circ}\text{C}$  should be used.
- \*\* Tolerance of 5 percentage points on the maximum value of the range for each sieve except 1/2" (12.5 mm) and 3/8" (9.5 mm) sizes, on which no tolerance will be allowed.

#### 6. Moisture Content

Moisture content shall not exceed 4.8% when determined as follows:

% Moisture = 
$$(W_1 - W_2) / (W_1) \times 100$$

where:  $W_1$  = Initial weight of sample

 $W_2$  = Weight of sample after drying to a constant weight at  $110^{\circ}$ C  $\pm$  5°C.

NOTE: Procedure shall be in accordance with American Water Works Association B200-88, Section 4.3. A tolerance of 0.5% will be allowed before a non-complying product - moisture - price deduction is assessed.

### 7. Sampling

Sampling shall be done in accordance with current ASTM-D632. The Authority, or any of its authorized representatives, reserves the right to take samples from the Vendor's stockpile or transfer point.

#### 8. Acceptance

The treated salt may be rejected if it fails to conform to any of the requirements of this specification.

### 9. Non-Complying Product - Price Deductions

a. Non-Complying Product - Price Deduction - Moisture

If the moisture content of the treated salt is found to be above 5.3%, a deduction for moisture content will be made from the delivered bid price based on the following formula:

Reduced Price/Ton = Delivered Contract Price/Ton x (1.106 - 2x) where: X = Moisture content of the sample (expressed as the decimal equivalent of the percentage of the moisture content to the nearest 1%)

b. Non-Complying Product - Price Deduction - Gradation (Particule Size Distribution)
If, after delivery, the gradation of the treated salt is found to be out of tolerance, a deduction from the price shall be made based on the following formula:

Reduced Price/Ton = Delivered Contract Price x (1.00 - Y)

where: Y = the decimal equivalent of the total percentage of the sample out of gradation. The percentage out of tolerance for each sieve shall be to the nearest 1%. The total of the individual sieve tolerance deviations shall be used as Y.

#### c. General

A non-complying product - price deduction is not to be assessed unless the proper analysis and test procedures are followed. If the Vendor consistently delivers salt found to be above 2% moisture content or consistently not conforming to the graduation requirements, the contract shall be subject to cancellation either in whole or in parts.

#### 10. Calculations

Calculations performed relative to this specification shall be made using the rounding off method of "ASTM Recommended Practice E-29 for Designating Significant Places in Specified Limiting Values".

#### 11. Corrosion rating of treated salt

A 3% solution of the treated salt product shall have a corrosion value of at least 50% less than that of a 3% solution of Sodium Chloride. (Determined by NACE (National Association of Corrosion Engineers) - Standard TM-01-69 as modified by PNS (Pacific Northwest Snowfighters)).

#### G. Performance and Reliability

It is the intent of the Authority and is in the best interests of Authority patrons, to operate and maintain the safest facility possible, especially during winter storms. The Authority must be assured that the OBPE must be safe for use on Authority facilities. Therefore, the product must meet the performance and reliability specification listed below:

1. The product must have a five-year history of satisfactory use on a facility similar to the New Jersey Turnpike Authority. This should be included in the Qualification Questionnaire (p. 32). A similar facility is defined as:

A HIGH SPEED, HIGH VOLUME LIMITED ACCESS ROADWAY LOCATED IN THE NORTH EAST, NORTH CENTRAL OR NORTH WEST UNITED STATES.

Bidders submitting bids for alternate products shall complete the Exception Form, Section IV; A.

### INSTRUCTIONS TO BIDDERS FOR SUBMISSION OF BIDS STANDARD TERMS AND CONDITIONS

The following Standard Terms and Conditions apply to all contracts, purchase agreements or purchase orders with the New Jersey Turnpike Authority unless specifically stated otherwise in the Invitation to Bid/Request for Bids ("RFB"). Bidders are hereby notified that all Terms and Conditions contained herein will become a part of any contract(s) awarded or order(s) placed as a result of any RFB fully and to the same extent as if copied at length therein. In the case of a conflict between these general Terms and Conditions and the specific provisions of the RFB, the RFB shall control. Failure to comply with each and every one of the below Terms and Conditions, as well as the specific requirements set forth in the RFB, may be grounds for rejection of the bid.

#### I. DEFINITIONS

The following definitions will be a part of any RFB issued by the New Jersey Turnpike Authority, and any contract(s) awarded or order(s) placed as a result of such documents.

- a. "Authority" shall mean the New Jersey Turnpike Authority.
- b. "Bidder" shall mean any potential vendor submitting a response to an RFB issued by the Authority.
- c. "Contract" shall mean the RFB (including these Standard Terms and Conditions), the response thereto submitted by the bidder, and the Authority's Notice of Award.
- d. "Director" shall mean the Director of Procurement & Materials Management Department of the Authority.
- e. "Vendor" shall mean the successful bidder who is awarded the contract at issue.

#### II. STATE LAWS REQUIRING MANDATORY COMPLIANCE BY ALL BIDDERS

**A. DIVISION OF REVENUE REGISTRATION-**Pursuant to the terms of *N.J.S.A.* 52:32-44, bidders are required to submit to the Authority proof of valid business registration with the New Jersey Division of Revenue in the Department of Treasury, prior to entering into a contract with the Authority. No contract shall be entered into by the Authority unless the bidder first provides proof of valid business registration. In addition, bidders are required to provide to the Authority proof of valid business registration with the Division of Revenue for any and all subcontractors that will be used to provide goods or services under the contract. ELECTIONS TRANSPARENCY ACT, P.L. 2023, c. 30; FAIR AND OPEN EXCEPTION -** In accordance with the Elections Transparency Act, P.L. 2023, c. 30 (the "Act"), effective January 1, 2023, all contracts awarded by the Authority pursuant to a fair and open process as defined in the Act are no longer subject to the political contributions proscription that prohibited a contract award if certain reportable contributions were solicited or made by a potential contract awardee. The Authority has determined that this procurement meets the requirements of a fair and open process and, accordingly, any such solicited or reportable contributions made by any [bidder submitting a bid][proposer submitting a proposal][person or entity submitting a response to this procurement] will not prohibit any contract award thereto if such [bidder is deemed the lowest, responsible bidder][proposer is deemed the successful proposer][respondent is deemed the successful respondent].

### 1. ANNUAL REPORT OF CONTRIBUTIONS TO ELECTION LAW ENFORCEMENT COMMISSION

All Business entities are advised of their responsibility to file an annual disclosure statement of political contributions with the New Jersey Election Law Enforcement Commission (ELEC) pursuant to N.J.S.A. 19:44A-20.27 if they receive contracts in excess of \$50,000.00 from public entities in a calendar year. Business entities are responsible for determining if filing is necessary. Additional information on this requirement is available from ELEC at 888-313-3532 or at <a href="https://www.elec.state.nj.us">www.elec.state.nj.us</a>

- **E. PREVAILING WAGE ACT**-The New Jersey Prevailing Wage Act, *N.J.S.A.* 34:11-56.26 et seq., is hereby made a part of every contract entered into on behalf of the Authority, except those contracts which are not within the contemplation of the Act. The bidder's signature on its bid is its guarantee that neither it nor any subcontractors it might employ to perform the work covered by the contract has been suspended or debarred by the New Jersey Department of Labor and Workforce Development for violation of the provisions of the Prevailing Wage Act and/or the Public Works Contractor Registration Act. The bidder's signature on its bid is its guarantee that both it and any subcontractors it might employ to perform the work covered by the contract will comply with the provisions of the Prevailing Wage and Public Works Contractor Registration Acts, where required.
- **F. PUBLIC WORKS CONTRACTOR REGISTRATION ACT**-The New Jersey Public Works Contractor Registration Act requires all contractors, subcontractors and lower tier subcontractors who bid on or engage in any contract for "public work," as defined in *N.J.S.A.* 34:11-56.51, to be first registered with the Department of Labor and Workforce Development. No vendor or subcontractor, including lower tier subcontractors, shall engage in the performance of any public work subject to the contract unless they are registered pursuant to this Act. Bidders can submit a valid copy of their Public Works Contractor Registration Certificate and valid copies of the Registration Certificates for all subcontractors along with the bid, but the certificate(s) must be submitted prior to contract award. The Registration

Certificate(s) shall be maintained at the worksite and shall be made readily available for inspection at any time. Pursuant to *N.J.S.A.* 34:11-56.55 applications for registration shall not be accepted as a substitute for a Registration Certificate for subcontractors.

Any questions regarding this requirement should be directed to the Division of Wage and Hour Compliance, Department of Labor and Workforce Development at (609) 292-9464.

- **G. FOREIGN CORPORATION**-If applicable, the bidder shall register as a "Foreign Corporation" with the Secretary of the State of New Jersey, designating a resident agent for the service of process. Foreign corporations must obtain a certificate of authority to do business in NJ pursuant to *N.J.S.A.* 14A:13-3. Written proof of such registration must be included with the bid submission.
- H. SMALL BUSINESS ENTERPRISE SET-ASIDE CONTRACT FOR GOODS AND SERVICES

  It is the policy of the Authority that small business enterprises ("SBE") as determined and defined by the State of New Jersey, Division of Revenue and Enterprise Services ("Division") in the Department of the Treasury (N.J.A.C.17:13-1.2) have the opportunity to compete for and participate in the performance of contracts and subcontract for construction and for the purchase of goods and services. The Authority further requires that its contractors/vendors agree to take all necessary and responsible steps, in accordance with N.J.S.A. 52:32-17 et seq. and N.J.A.C. 17:13-1 et seq. to ensure that SBE's have these opportunities, as an aid in meeting the commitment of its SBE Programs. When applicable the Authority will designate the contract as a SBE Set-Aside Contract. In such cases requests for bid proposals shall be confined to businesses registered with the Division as an SBE in either Category 1, 2, or 3. Bid proposals from businesses not designated as an SBE, when applicable, will be rejected.
- I. CODE OF ETHICS: Bidders are advised that the Authority has adopted the New Jersey Uniform Code of Ethics, a copy of which can be viewed by going to the following web site: <a href="http://nj.gov/ethics/docs/ethics/uniformcode.pdf">http://nj.gov/ethics/docs/ethics/uniformcode.pdf</a> By submitting a bid, bidders agree to be subject to the intent and purpose of said Code and to the requirements of the New Jersey State Ethics Commission.
  - 1) No vendor shall pay, offer to pay, or agree to pay, either directly or indirectly, any fee, commission, compensation, gift, gratuity, or other thing of value of any kind to any State officer or employee or special State officer or employee, as defined by *N.J.S.A.* 52:13D-13b. and e., in the Department of the Treasury or any other agency with which such vendor transacts or offers or proposes to transact business, or to any member of the immediate family, as defined by *N.J.S.A.* 52:13D-13i., of any such officer or employee, or any partnership, firm, or corporation with which they are employed or associated, or in which such officer or employee has an interest within the meaning of *N.J.S.A.* 52:13D-13g.
  - 2) The solicitation of any fee, commission, compensation, gift, gratuity or other thing of value by any State officer or employee or special State officer or employee from any State vendor shall be reported in writing forthwith by the vendor to the Attorney General and the Executive Commission on Ethical Standards.
  - 3) No vendor may, directly or indirectly, undertake any private business, commercial or entrepreneurial relationship with, whether or not pursuant to employment,

contract or other agreement, express or implied, or sell any interest in such vendor to, any State officer or employee or special State officer or employee having any duties or responsibilities in connection with the purchase, acquisition or sale of any property or services by or to any State agency or any instrumentality thereof, or with any person, firm or entity with which he is employed or associated or in

which he has an interest within the meaning of *N.J.S.A.* 52:13D-13g. Any relationships subject to this provision shall be reported in writing forthwith to the Executive Commission on Ethical Standards, which may grant a waiver of this restriction upon application of the State officer or employee or special State officer or employee upon a finding that the present or proposed relationship does not present the potential, actuality or appearance of a conflict of interest.

- 4) No vendor shall influence, or attempt to influence or cause to be influenced, any State officer or employee or special State officer or employee in his official capacity in any manner which might tend to impair the objectivity or independence of judgment of said officer or employee.
- 5) No vendor shall cause or influence, or attempt to cause or influence, any State officer or employee or special State officer or employee to use, or attempt to use, his official position to secure unwarranted privileges or advantages for the vendor or any other person.
- 6) The provisions cited shall not be construed to prohibit a State officer or employee or special State officer or employee from receiving gifts from or contracting with vendors under the same terms and conditions as are offered or made available to members of the general public subject to any guidelines the Executive Commission on Ethical Standards may promulgate as stated above.
- **J. VENDOR LOCATION DISCLOSURE-**Pursuant to *N.J.S.A.* 52:34-13.2, every contract entered into by the Authority primarily for the performance of services shall specify that all services performed under the contract or performed under any subcontract awarded under the contract shall be performed within the United States. The statute requires all bidders to disclose the origin and location of the performance of their services, including any subcontracted services that are the subject matter of the contract. Bidders must include with their bid a completed Vendor Disclosure Form, attached hereto as Exhibit F.
- **J-1 DISCLOSURE OF INVESTMENT ACTIVITIES IN IRAN-** Pursuant to *N.J.S.A.* 52:32-58, the bidder must certify that neither the bidder, nor one of its parents, subsidiaries, and/or affiliates (as defined in *N.J.S.A.* 52:32-56(e)(3)), is listed on the Department of the Treasury's List of Persons or Entities Engaging in Prohibited Investment Activities in Iran and that neither is involved in any of the investment activities set forth in *N.J.S.A.* 52:32-56(f). If the bidder is unable to so certify, the bidder shall provide a detailed and precise description of such activities. Bidders must include with their bid a completed Disclosure of Investment Activities in Iran, attached hereto as Exhibit F-1.

**J-2 CERTIFICATION OF NON-INVOLVEMENT IN PROHIBITED ACTIVITIES IN RUSSIA OR BELARUS-** N.J.S.A. 52:32-60.1 et seq. (P.L. 2022, C.3) (the "Act") states that prior to contract award, the awardee must certify that neither the awardee, nor any of its parents, subsidiaries, or affiliates engaged in prohibited activities in Russia or Belarus. However, the enforceability of N.J.S.A. 52:32-60.1 et seq. was challenged in the United States District Court for the District of New Jersey. On December 22, 2023, a company obtained a permanent injunction from the United States District Court, which enjoined the State from enforcing N.J.S.A. 52:32-60.1 on the ground that it would conflict with the existing federal sanctions regime and the United States Constitution's Supremacy Clause.

N.J.S.A. 52:32-60.4 provides that the Act "shall not apply in circumstances when its application would violate federal law." Accordingly, to enforce the Act in a manner consistent with the District Court's decision and federal law, New Jersey deems its list of persons and entities engaging in prohibited activities in Russia or Belarus to consist of all persons and entities appearing on the list of Specially Designated Nationals and Blocked Persons promulgated by the United States Department of Treasury, Office of Foreign Assets Control (OFAC), on account of activity relating to Russia or Belarus. A searchable database of OFAC-listed persons and entities is available here: <a href="https://sanctionssearch.ofac.treas.gov/">https://sanctionssearch.ofac.treas.gov/</a>.

Consistent with the District Court's decision, the State of New Jersey has revised its *Certification of Non-Involvement in Prohibited Activities in Russia or Belarus* form. Accordingly, prior to entering into any Agreement(s) hereunder, Successful Proposer(s) shall be required to complete and submit to NJTA the revised *Certification of Non-Involvement in Prohibited Activities in Russia or Belarus* (Exhibit F-2).

- **K. SET-OFF FOR OUTSTANDING TAX LIABILITY-**Bidders are advised that pursuant to <u>P.L.</u> 1995, <u>c.</u> 159, effective January 1, 1996, and notwithstanding any provision of the law to the contrary, the State of New Jersey has the right to set-off any tax indebtedness from payments made under contracts with the Authority. The State's rights are explained in more detail in Exhibit G, attached. Bidders must provide a copy of Exhibit G acknowledging that they have received notice of the State's right of set-off prior to contract award.
- **L. MSDS REQUIREMENTS**-Any vendor, Vendor, or subcontractor who provides the Authority materials in the form of a single chemical substance or a mixture containing two or more chemical substances, or who delivers to or stores such materials at an Authority facility, must provide the Authority with a clear, legible copy of the manufacturer's most recent Material Safety Data Sheet (MSDS) for each and every one of those materials, pursuant to *N.J.A.C.* 8:59-2.2(i).
- **M. LABELING REQUIREMENTS**-Any vendor, Vendor or subcontractor who provides the Authority materials which fall under the purview of the New Jersey Worker and Community Right-to-Know-Act, *N.J.S.A.* 34:5A-1 et seq., or who stores any such materials at an Authority facility, shall ensure that each and every container of those materials is labeled in accordance with the Act and its regulations.

- **N. VOC REQUIREMENTS-**Any architectural coating, as defined by *N.J.A.C.* 7:27-23.2, provided to the Authority for its use or used and applied by any vendor or subcontractor in conjunction with an Authority project must comply with each and every requirement of the New Jersey Department of Environmental Protection's Volatile Organic Compounds in Consumer Products (VCC) regulation, *N.J.A.C.* 7:27-23.1 et seq.
- O. COMPLIANCE WITH STATE AND FEDERAL LAWS-The vendor must comply with all local, state and federal laws, rules and regulations applicable to the contract at issue and to the work to be done thereunder.
- P. SAFETY & HEALTH REQUIREMENTS-The goods, services and/or equipment provided through the contract at issue shall be so designed and installed to meet all applicable federal and state safety and health regulations and national consensus standards including, but not limited to US DOL-OSHA, NJ LWD-PEOSHA, NFPA and ANSI standards
- **Q. CHOICE OF LAW**-It is agreed and understood that any contract entered into and/or purchase orders placed as a result of any RFB issued by the Authority shall be governed and construed and the rights and obligations of the parties thereto shall be determined in accordance with the laws of the STATE OF NEW JERSEY.

#### III. <u>BID PREPARATION</u>

**A. BID SUBMISSION**-Unless the Authority has made provision for bids to be submitted online, bids must be submitted in paper format, in ink or typewritten. If space is provided on the RFB for bid details, bids must be submitted using that document. Paper bids must be signed and returned in a sealed envelope addressed to the New Jersey Turnpike Authority with the bid opening date, time and bid identification on the outside of the envelope. Bidders shall state on such form a unit price for each item and extend such unit price by multiplying same by the indicated quantities on the bids solicited by the Authority.

All bids must be received in the Authority's Purchasing Department on or before the date and time specified on the RFB. Bids received after the time indicated shall be rejected and returned to the bidder(s) unopened after being processed in accordance with established Authority procedures. The Authority will not be responsible for late postal or delivery service.

- **B. CORRECTIONS-**Any correction of an entry made on the bid should be initialed by a duly authorized representative of the bidder. If the total price is found to be incorrectly computed, discrepancies will be corrected by the Authority on the basis of the written unit prices, and determination of the low bidder will be made on the basis of the correct total price so determined.
- **C. BID PRICES-**All prices quoted shall be firm and not subject to increase during the term of the contract, unless otherwise specified in the RFB. Prices shall include transportation and delivery to the site designated by the Authority in the RFB. All delivery charges shall be borne by the vendor.
- **D. PAYMENT TERMS**-The bidder shall state the terms, if any, requested for the Authority to make payment within a certain period of time after receipt of the bidder's invoice.
- **E. ALTERNATES-**All items are to be quoted as specified in the RFB or as an approved equivalent. In those cases when an alternate product is offered, it is the bidder's responsibility to provide detailed specifications, brand, make and model of the alternate offered, in the bidder's response/bid submission. In the event a bidder fails to take exception to the published bid specifications, the Authority shall evaluate the bid as offering the specified product/service. The Authority shall determine, at its sole discretion, if any alternate product offered is acceptable as an approved equivalent.

In the event the Authority specifies a model number or item that has been replaced/superseded by another model number or item, the bidder may quote the replacement item as an alternate. In this case, the bidder must specify the manufacturer and model number of the replacement item on the response/bid submission and must supply detailed descriptive literature and/or prints with that submission. The Authority will evaluate the proposed item to determine, in its sole discretion, whether it is an approved equivalent.

#### IV. BIDDER GUARANTEES AND MISCELLANEOUS CONTRACT REQUIREMENTS

**A. WARRANTY**-The bidder hereby represents and warrants that the equipment offered is standard new equipment, latest model of regular stock product, with parts regularly used for the type of equipment offered, that such parts are all in production and none likely to be discontinued; also, that no attachment or part has been substituted or applied contrary to manufacturer's recommendations and standard practice.

The bidder shall unconditionally guarantee all new equipment for a term of one year from time of acceptance by the Authority unless specified otherwise in the RFB and shall render prompt service of such equipment without charge, regardless of geographic location. The bidder shall maintain sufficient quantities of parts necessary for proper service to equipment at distribution points and service headquarters.

- **B. BID SECURITY-**Bidder shall submit with its bid proposal, fully executed by its bonding company and itself, either: (1) the standard form Authority Letter of Surety (attached hereto as Exhibit H), or (2) the standard form Authority Proposal Bond (attached hereto as Exhibit I), in the amount of 10% of its bid price. In lieu of the Letter of Surety or Proposal Bond, the bidder may elect to furnish with its bid proposal a <u>Cashier's check</u> in the amount of 10% of the bid price as a performance warranty deposit. This bid surety will be held by the Authority until award of the contract to ensure compliance by the successful bidder with the terms and obligations of the bid including, but not limited to, delivery date.
- C. CONTRACT BOND-The vendor shall, within ten (10) calendar days of receipt of the Notice of Award, furnish and deliver the Contract Bond on the standard form of the Authority, attached hereto as Exhibit J. The Contract Bond shall be in a sum of up to 100% of the total amount bid for the contract, as specified in the RFB, and shall be maintained by the vendor until final payment is made. In the event of insolvency of the Surety, the vendor shall forthwith furnish and maintain other Surety satisfactory to the Authority.
- D. ELECTRONIC PAYMENT With the award of this contract, the successful vendor(s) will be required to receive their payment(s) electronically and invoices should be emailed to; invoicefb@njta.com In order to receive your payments via automatic deposit from the Authority, complete and return the "Authorization Agreement for Direct Payments (ACH Credits)" Form with an original voided check or bank letter. The form must include ABA number (routing or transit number), bank account number and if the bank account is a checking or savings account. The form and instructions are located in the Instruction to Bidders on the Authority's website <a href="http://www.state.nj.us/turnpike/purchasing.html">http://www.state.nj.us/turnpike/purchasing.html</a>. The completed form along with the required voided check or bank letter should be emailed to achvendor@njta.com

**E. NON-COLLUSION-**. The bidder's signature on its bid is its guarantee that said bidder has not, directly or indirectly, entered into any agreement, participated in any collusion, or otherwise taken any action in restraint of free, competitive bidding in connection with the referenced contract; and that all statements contained in the bid and any additional statements requested by the Authority are true and correct, and made with full knowledge that the Authority relies upon the truth of the statements contained therein in awarding the contract.

The bidder's signature on its bid is its guarantee, in accordance with *N.J.S.A.* 52:34-15, that no person or selling agency has been employed or retained to solicit or secure such contract upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, except bona fide employees or bona fide established commercial or selling agencies maintained by the bidder for the purpose of securing business.

#### V. <u>INSURANCE AND INDEMNIFICATION</u>

A. INSURANCE-The bidder shall procure and maintain at its own expense for the entire term of the contract insurance for liability for damages imposed by law and assumed under this contract, of the kinds and in the amounts hereinafter provided. All insurance companies used must be authorized to do business in the State of New Jersey and must carry an A.M. Best Rating of A-/VII or better. Before commencing any services hereunder, the bidder shall furnish to the Authority a certificate(s) of insurance. The Authority reserves the right to request and obtain complete copies of all insurance policies showing that it has complied with this Section. All certificate(s) and notices of cancellation or change shall be mailed to: Director, Purchasing Department, New Jersey Turnpike Authority, P.O. Box 5042, Woodbridge, New Jersey 07095. Upon request, the bidder shall furnish the Authority with a certified copy of each policy itself, including the provision establishing premiums.

The type and minimum limits of insurance shall be:

1. <u>Commercial General Liability Insurance.</u> The minimum limits of liability for this insurance per accident shall be as follows:

•	Bodily injury and property damage each occurrence	\$2,000,000.00
•	Personal injury each occurrence	\$2,000,000.00
•	General Aggregate	\$2,000,000.00
•	Products and Completed Operations Aggregate	\$2,000,000.00
•	Fire Damage Legal Liability	\$100,000.00
•	Medical Payments	\$5,000.00

The above required Commercial General Liability Insurance shall name the Authority, its Commissioners, officers, employees, and agents as additional insureds. The coverage to be provided under this policy shall be provided on the ISO CG 00 01 Form or its equivalent. The insurance policy shall be endorsed to include Personal Injury, Broad Form Property Damage, Contractual Liability (including the deletion of the coverage restriction related to work conducted within fifty (50) feet of a railroad), Products/Completed Operations, Independent Consultants and XCU if applicable. Products/Completed Operations coverage shall remain in force for a period of two (2) years following the completion and/or termination of the contract.

2. <u>Business Automobile Liability Insurance.</u> The Comprehensive Automobile Liability policy shall cover owned, non-owned, and hired vehicles with minimum limits as follows:

Combined Single Limit of Liability for Bodily Injury or Property Damage for any one accident: \$2,000,000. This policy shall include an endorsement amending the Contractual Liability coverage to delete the exclusion for work done within fifty feet of the railroad, an MCS 90 as required by law and the ISO CA 99 48.

This policy shall name the Authority, its Commissioners, officers, employees, and agents as additional insured.

3. Workers Compensation and Employers' Liability Insurance. Workers Compensation Insurance shall be provided in accordance with the requirements of the laws of the State of New Jersey and shall include an All-States endorsement or similar statement in the policy declarations, extending coverage to any state which may be interpreted to have legal jurisdiction. Employers' Liability Insurance shall be provided with a limit of liability of not less than \$1,000,000 for each accident.

#### 4. Umbrella Liability Insurance.

Umbrella liability insurance is required with limits **in excess** of those underlying policies stated under parts (a) Commercial General Liability, (b) Commercial Automobile Liability and (c) Employers' Liability with minimum limits as follows:

Minimum limit each occurrence and annual aggregate......\$3,000,000 Limits can be achieved in any combination of primary and excess limits.

This policy shall name the Authority, its officers, employees, and agents as additional insured.

#### 5. Certificate and Endorsement Requirements

Each of the above required policies shall contain the endorsements as stated below:

- (a) Sixty (60) days' notice of cancellation or any restriction in coverage by registered mail to the Authority.
- (b) All policies, except Workers Compensation and Employers' Liability Insurance, shall contain a waiver of subrogation clause in favor of the Authority.
- (c) With respect to the Workers' Compensation and Employers' Liability, this policy shall contain a waiver of subrogation in favor of the Authority, where allowed by law.
- (d) With respect to Commercial General Liability and Automobile Liability policies, the other insurance clause under each policy shall be amended to read as follows: "This policy will act as primary insurance and not contribute with policies issued to the Authority."

The vendor shall also require that all of its contracting parties comply with the insurance requirements stated above including providing evidence of such insurance coverages in the same manner as stated above.

Due to future changes in economic financial and/or insurance market conditions the Authority at its discretion may modify the above stated insurance requirements.

NOTWITHSTANDING THAT MINIMUM AMOUNTS OF INSURANCE COVERAGE CARRIED OR REQUIRED TO BE CARRIED BY THE BIDDER ARE SPECIFIED HEREIN, THE LIABILITY OF THE BIDDER SHALL NOT BE LIMITED TO THE AMOUNTS SO SPECIFIED AND SHALL EXTEND TO ANY AND ALL LIABILITY IN EXCESS OF THE INSURANCE COVERAGES SO PROVIDED NOR SHALL THESE MINIMUM LIMITS PRECLUDE THE AUTHORITY FROM TAKING ANY ACTION AVAILABLE TO IT UNDER THE PROVISIONS OF THE CONTRACT OR OTHERWISE IN LAW.

- В. INDEMNIFICATION-Vendor agrees to defend, indemnify and save harmless the Authority, its Commissioners, officers, employees, and agents and each and every one of them against and from all liabilities, judgments, threatened, pending or completed actions, suits, demands for damages or costs of every kind and description actually and reasonably incurred (including attorney's fees and costs and court costs) (collectively "Liabilities") including, without implied limitations, Liabilities for damage to property or Liabilities for injury or death of the officers, agents and employees of either the vendor or the Authority, resulting from any act or omission or willful misconduct of the vendor or any of its officers, agents, sub-consultants, or employees in any manner related to the subject matter of the contract. In the event that the vendor fails to defend, indemnify and save harmless the Authority, its Commissioners, officers, employees, and agents, and each and every one of them, in accordance with this Section, any money due to the vendor under and by virtue of the contract as shall be considered necessary by the Authority may be retained by the Authority and held until any and all liabilities shall have been settled and suitable evidence to that effect furnished to the Authority. The obligations in this Section shall survive the termination, expiration or rescission of the contract.
- **C. PATENT INDEMNIFICATION**-The vendor hereby agrees that it will indemnify, defend, and save harmless the Authority, its Commissioners, officers, agents and servants from all suits, actions, claims and judgments of any kind or character whatsoever for infringement of patent, trademark or copyright regarding the items bid herein that may be brought by any person, corporation, or firm.

#### VI. <u>DELIVERY REQUIREMENTS</u>

- **A. DELIVERY DATE**-A FIRM delivery date must be stated on the bid. Statements such as "stock" or "immediate" are not acceptable. Where the RFB calls for delivery within a specified time, it shall be indicated in the bid whether delivery will be made within the time specified.
- **B. F.O.B.**-Price shall include delivery to the Authority F.O.B. destination, freight paid to any destination on the New Jersey Turnpike or Garden State Parkway. No additional charge will be allowed for any transportation cost resulting from partial shipments made at vendor's convenience when a single shipment is ordered. Prices quoted are firm throughout the term of the contract for complete delivery of quantities specified.

Bids submitted on an F.O.B. destination basis are mandatory; however, in instances where customs of the trade or unusual circumstances dictate F.O.B. shipping point, an estimate of the shipping charges must be noted on the bid and may be accepted in the Director's sole discretion. In such cases, actual shipping charges are to be prepaid and added to the invoice.

#### **C. DELIVERY-**Upon award of the contract:

- 1. Deliveries shall be made at such time and in such quantities as ordered in strict accordance with conditions stated in the RFB.
- 2. Deliveries may be set on a scheduled basis as arranged between the Authority and the vendor. It shall be the responsibility of the vendor to maintain an adequate supply stock.
- 3. The vendor will be responsible, at the point of delivery, for the delivery of material in such quality and condition as required by Paragraph IV.A. hereof and in accordance with good commercial practice.
- 4. Items delivered must be strictly in accordance with those bid upon.
- 5. As applicable, bidders must state in the space provided on the RFB/bid solicitation documents the number of days required to make delivery after notification to ship.
- 6. In the event delivery is not made within the number of days stipulated, the Authority may purchase the required material from any available source. The difference in price, if any, will be paid by the vendor failing to meet its commitments.

#### VII. OTHER TERMS AND CONDITIONS

- A. CONTRACT PERIOD- Except as otherwise stated in the RFB, the term of the contract shall be for one (1) year, with the option to extend for two (2) one-year options, at the Authority's discretion, and with vendor's concurrence.
- **B. EXTENSION OPTION**-If, in the opinion of the Director, it is in the best interest of the Authority to extend any contract beyond the original term, for a period of all or any part of a year, the vendor will be so notified of the Director's intent, prior to the expiration date of the existing contract. The Authority reserves the right to make up to two extensions of this contract for not more than one year each. If the extension is acceptable to the Authority at the original prices and on the original terms, notice will be given to the vendor by the Director in writing. If the original contract required a Contract Bond, a new Contract Bond must be submitted to cover the period of the extension. The same insurance requirements will be required for each extension period.
- C. TERMINATION OF CONTRACT-The contract awarded may be terminated by the Authority at any time for inadequate or improper performance, or for breach of any terms, conditions, or obligations of the contract by the vendor, as determined by the Authority, or if the vendor shall make an assignment for the benefit of creditors, or file a voluntary petition in bankruptcy, or if an involuntary petition in bankruptcy is filed against the vendor and the act of bankruptcy therein alleged is not denied by the vendor, or if denied, is found by a court or jury. Further, the Authority reserves the right to terminate any contract for any reason provided written notice has been given by the Director to the vendor at least thirty (30) days prior to such proposed termination date.

The notice of termination shall be in writing and shall be effective upon receipt by the vendor. Upon termination, the Authority shall be liable only for payment for goods or services properly delivered or performed in accordance with the contract. The Authority shall have the right to purchase non-delivered goods, to replace defective goods or services on the open market and hold the vendor liable for the difference between the price set forth in the contract for such goods or services and the prices paid on the open market or pursue any other right available by law. In addition, the Authority shall have the right, without the necessity of court proceedings, to recover all equipment, material or supplies that are the property of the Authority and have been entrusted with the vendor to be used in the performance of said contract. Nothing in this paragraph is intended to limit the Authority's right to legally pursue all costs which exceed the amount due and owing the vendor under said contract. The list of remedies in this paragraph is not exclusive.

- **D. SCOPE-**The total quantities of any contract are estimated. There is no guarantee of any minimum quantity. It is understood and agreed that contract prices shall cover the quantities actually required and ordered by the Authority during the term of the contract, whether more or less than the approximate quantity stated.
- **E. BIDDERS FACILITIES**-The Authority reserves the right to inspect the bidder's establishment before making an award.
- **F. TESTING**-The Authority reserves the right to have the material tested prior to the award and during the contract by an independent testing laboratory, to determine if the material meets the specifications of the RFB. If required for testing purposes, the low bidder shall submit a reasonable quantity of the product as samples. If these samples prove satisfactory, the contract shall be awarded. If they do not prove satisfactory, a test shall be made of the next low bidder's sample, until satisfactory products are found to meet requirements. Should the laboratory find that any shipment does not meet specifications, the Authority shall have the right to reject same.
- **G. INSPECTION** All work done and supplies furnished shall be subject to inspection, testing and rejection by the Authority, or its representatives, at all times and places, both during manufacture and at destination. After award of the contract, should the result of any test or inspections show that the material supplied fails to meet the requirements of the Authority, the material shall be rejected and immediately replaced by the vendor. Rejected supplies or materials will be returned at the vendor's risk, and all inspection, handling, and transportation charges to and from the Authority's delivery site will be assumed by the vendor. The vendor shall bear any and all expenses resulting from delay caused by failure to meet test or inspection standards. Should the Authority for any reason decide to accept any shipment which fails to meet specifications, the Authority may make an appropriate price adjustment with regard to same.
- **H. AWARDS-**Comparison of bids will be based on the total price stated in the bid and an award will be based on the total price, terms and delivery date given by the bidder. If the total price is found to have been incorrectly computed, discrepancies will be corrected by the Authority on the basis of the unit prices and a determination of the low bidder will be made on the basis of the corrected total price. The Authority shall not be liable for any failure on its part to detect or correct errors, and the Authority's action in connection therewith shall not give rise to any rights to the bidder.

- I. NOTICE TO VENDORS AND AUTHORITY DEPARTMENTS-The Authority is authorized to order, and vendors are authorized to ship only those items covered by the contract. If a review of orders placed by the Authority reveals that material other than that covered by the contract has been ordered and delivered, the Director will take such steps as are necessary to have the material returned regardless of the time elapsed between the date of delivery and discovery of the violation. A full refund to the Authority by the vendor will be required.
- **J RIGHT TO AUDIT-**Vendor shall keep and maintain proper and adequate books, records and accounts accurately reflecting all costs and amounts billed to Authority under the contract at issue. Authority, its employees, officers, or representatives shall have the right upon written request and reasonable notice, to inspect and examine all of the vendor's books and records related to the contract. Such records shall be retained by vendor for at least five (5) years from the termination of the contract. In no event shall books and records be disposed of or destroyed of prior to five (5) years from the termination of the contract or during any dispute or claim between the Authority and vendor with regard to the contract at issue.
  - 1. In accordance with the New Jersey Office of the State Comptroller ("OSC") document retention policy *N.J.A.C.* 17:44-2.2 The vendor shall maintain all documentation related to products, transactions, or services under this contract for a period of five years from the date of final payment. Such records shall be made available to the OSC upon request.
- **K. TAXES**-The Authority is exempt from Federal Excise Tax, New Jersey State Sales and Use Tax and other tax as applicable.
- **L. TRANSFER OF BUSINESS**-It is understood by all parties that, if, during the term of the contract, the vendor disposes of its business by sale, transfer or by any means to another party, all obligations are transferred to such purchaser.
- **M. INTERAGENCY COOPERATIVE PURCHASING**-Pursuant to *N.J.S.A.* 27:23-6.1(a), vendors may receive inquiries by the entities listed below, with respect to extending this contract to them based upon the same prices, terms, and conditions:

**N. CONTRACT CHANGES**-During the term of contract, no change will be permitted in any of its conditions and specifications unless the vendor receives written approval from the Director.

Should the vendor find at any time that existing conditions make modification in requirements necessary, the vendor shall promptly report such matter to the Director for consideration and decision.

- **O. SUBCONTRACTING OR ASSIGNMENT**-The contract may not be subcontracted or assigned by the vendor, in whole or in part, without the prior written consent of the Director. In the event that bidder proposes to subcontract some or all of the services to be provided under the contract, it shall state so in its bid and attach for approval a list of said subcontractors and an itemization of the goods and/or services to be supplied by them.
- **P. REJECTION OF BIDS**-Failure to comply with mandatory requirements of the bid shall be considered grounds for rejection. The Authority retains the right to reject any or all bids, to waive informalities and minor irregularities and to rebid the entire contract.
- **Q. LIABILITIES OR DEBTS OWED TO THE AUTHORITY-** The failure by any Contractor or subcontractor during the term of the Contract to satisfy in a timely manner any outstanding debts or fees owed to the Authority, whenever incurred, including but not limited to those related to nonpayment of tolls or administrative fees, as required by *N.J.A.C.* 19:9-1.19 and *N.J.A.C.* 19:9-9.2, shall be grounds for suspension or termination of the Contract, in the sole discretion of the Authority.
