Subpart 602.03.03 of the Standard Inputs and the 2019 Standard Specifications for Road and Bridge Construction has been revised to clarify the requirements and therefore to prevent misunderstanding and claims from the contractors.

The following revisions have been incorporated into the 2019 Standard Specifications via 2019 Standard Inputs, SI2019:

602.03.03 Set Casting, Reset Casting, and Reconstructed Inlet and Manhole THE FIRST PARAGRAPH IS CHANGED TO:

When modifying less than 1 foot of an inlet or manhole, set a new casting, or reset the existing casting. When modifying 1 foot or more of an inlet or manhole, reconstruct the inlet or manhole.

Implementation Code R (ROUTINE)

Changes must be implemented in all applicable Department projects scheduled for Final Design Submission at least one month after the date of the BDC announcement. This will allow designers to make necessary plan, specifications, and estimate/proposal changes without requiring the need for addenda or postponement of advertisement or receipt of bids.
