Request for Expressions of Interest**

**1. Inquiry:**

Based on the Anticipated OPS Schedule in the RFEIOI, each Contract has a different date for Phase D Submission and Start of Construction. Please provide clarification as to which Contract the required EOI Project Schedule should be based upon for the one 11x17 fold out page allowed.

Can we use two 11x17 for the project schedule?

**Response: Yes, one 11 x 17-fold out sheet will be allowed per Contract for project schedule.**

**2. Inquiry:**

Is the 11x17 Staffing estimate to include both T4200 and T4201 or is an 11x17 allowed for each Contract's Staffing estimate?

**Response: Yes, one 11 x 17- Staffing Estimate sheet will be allowed per Contract.**

**3. Inquiry:**

Please clarify. In Subsection A1 Expression of Interest Submission Requirements, Item 5, Project Schedule, is a separate project schedule to be submitted for each OPS?

**Response: Yes, A separate project schedule to be submitted for each OPS.**

**4. Inquiry:**

Are original forms with wet signatures required for the original copy?

**Response: Digital/Scanned versions are sufficient.**

**5. Inquiry:**

Are two 11X17 pages allowed for the Staffing Estimate (one page for each project)?

**Response: Yes, one page per OPS will be allowed.**

**6. Inquiry:**

Are two 11X17 pages allowed for the Project Schedule (one page for each project)?

**7. Inquiry:**

Subsection A1.4 – Please confirm if a separate staffing estimate shall be prepared per OPS or if one reflective of a single OPS will be reflective of either OPS.

Subsection A1. 5 – Please confirm if a separate project schedule shall be prepared per OPS or if one reflective of a single OPS will be reflective of either OPS.

Can the draft EO-215 document referenced on Page 23 of the RFEI be provided? If not, can a summary of the cultural resources survey report be provided (goal is to understand additional cultural resource survey requirements for Final Design)?
