TO ALL QUALIFIED FIRMS:

The original Solicitation for Requests for Expressions of Interests dated November 15, 2024, for OPS Nos. A4128, A4129, T4130 is hereby amended as noted in this Addendum No. 1, which shall become part of the OPS requirements.

Item No. 1 Solicitation Letter, Page No. 2 of 57

The second paragraph under "Staff Qualifications" is replaced with the following:

Key project personnel shall possess relevant training and experience demonstrating: (1) Successful completion of and effective scheduling for close-up, hands-on inspection and report submittals for major complex bridges with NSTMs in accordance with National Bridge Inspection Standards (NBIS); (2) FHWA SNBI, Element Level Inspection, and NJDOT SI&A data input and updating capabilities; (3) Proficiency in performing load ratings of complex bridge structures; and (4) Expertise in performing structural health monitoring (SHM) and non-destructive evaluation (NDE) of bridges. Project Managers, Team Leaders, Assistant Team Leaders, and Quality Control Engineers must meet the requirements outlined in the "Qualifications of Key Bridge Inspection Personnel" document on the Authority's website at <http://www.njta.com/doing-business/njta-bridge-inspect-program> under the heading "Bridge Inspection Program" and as summarized on the NJTA Bridge Inspection Qualification Summary Form and the Consultant Qualification Form (QAF3 Form). The QAF3 form is included within Appendix A of the NJTA Bridge Inspection Program Quality Management Plan. These factors will be critical elements in the selection process.
